Access, Zenith, four other banks paid N453.71bn levies, insurance premium to AMCON, NDIC in six months

The audited/unaudited reports of Access Holdings Plc and five other publicly-listed Nigerian banks revealed that they paid N453.71 billion as banking sector resolu-

tion costs and deposit insurance premiums to the Asset Management Corporation of Nigeria and Nigeria Deposit Insurance Corporation, respectively in the first half of 2024 that ended in June 2024.

The N453.71 billion represents about a 57.2 per cent increase from the N288.6 billion the six banks paid in the first half of 2023.

The other banks are Zenith Bank Plc, FBN Holdings Plc, Guaranty Trust Holding Company Plc (GTCO), Stanbic IBTC Holdings Plc, and FCMB Group Plc.

The banking sector resolution cost represents the AMCON's levy, which applies to the total balance sheet size of the bank.

The current applicable rate based on the AMCON Act of 2015 is 0.5 per cent of total assets plus total offbalance sheet assets.

AMCON was established in 2010 in a bid to stabilise the Nigerian banking system by efficiently resolving the non-performing loan assets of the banks in the economy.

Currently, it is being funded by a combination of loan recoveries, contributions from the Central Bank of Nigeria, sales of pledged assets, and a sinking fund assessed to the banks.

The Federal Government established AMCON with a 10-year mandate in response to the mounting bad loans and the requirement to prevent the bank-

In the period under review, Access Holdings

THE N453.71 BILLION REPRESENTS ABOUT A 57.2 PER CENT INCREASE FROM THE N288.6 BILLION THE SIX BANKS PAID IN THE FIRST HALF OF 2023. declared an AMCON levy of N112.2 billion in H1 2024, representing an increase of 63 per cent from the N68.81 billion reported in H1 2023, and N22.19 billion deposit insurance premiums in H1 2024, about 37.3 per cent increase from the N16.16 billion reported in H1 2023.

Access Holdings' N112.2 billion AMCON levy was due to a significant increase in the asset value of the newly restructured bank, which grew on the back of multiple mergers and acquisitions.

As of June 2024, Access Holdings reported N36.6 trillion in total assets, up from the N26.69 trillion reported in 2023 to emerge as the largest financial institution by total assets in Nigeria.

For Zenith Bank, its AMCON levy stood at N92.2 billion in H1 2024, which was about a 61 per cent increase from the N57.38 billion in H1 2023.

Zenith Bank had closed June 2024 with N27.6 trillion in total assets, a growth of 35 per cent from N20.4 trillion reported in 2023FY.

FBN Holdings announced a total N97.99billion as AMCON and NDIC expenses in H1 2024, about 58 per cent increase from the N61.9 billion in H1 2023, just as GTCO declared N49.2 billion as AMCON and NDIC expenses in H1 2024, up from the N35.9 billion declared in H1 2023.

According to GTCO, the AMCON levy increased by 33.6per cent to N36.6billion in H1 2024 from N27.4 billion in 2023 due to the growth in the underlying total Asset and contingents base at the bank level to N7.33trillion in 2023 from N5.46 trillion in 2022.

The AMCON Act 2019 (Amended) gives the corporation broader authority to pursue obligors for unpaid debts.

Additionally, helping eligible financial institutions efficiently dispose of eligible bank assets in compliance with the Act's rules is one of the key objectives of the Act.

Initially, banks were required to pay 0.3 per cent of all assets into the sinking fund.

In 2013 it was raised to 0.5 per cent of total assets (and 0.3 per cent of contingent liabilities).

The six banks' total assets hit N114.16 trillion as of June 2024, representing a growth of 37per percent from N83.3 trillion in the 2023 financial year.

The breakdown of the reports showed that Access Holdings paid the highest amount of N134.41 billion

"Also, Deposit Insurance premium increased by 48.3per cent (N12.5billion in H1 2024 vs. N8.4billion in H1-2023) due to a 26.3 per cent increase in underlying customers' deposit volume to N5.26 trillion in 2023 from N3.55 trillion in 2022 (Deposit Insurance Premium is calculated on preceding year's customers' deposits)," the bank explained in a presentation to investors and analysts.

While Stanbic IBTC Holdings declared N33.8billion as AMCON and NDIC expenses in H1 2024, up from N20.37 billion in H1 2023, FCMB Group posted N20.45billion as AMCON and NDIC expenses in H1 2024, representing a growth of 40 per cent from the N14.58 billion declared in H1 2023.

Kogi women protest alleged persecution of Yahaya Bello

huge crowd of women in Kogi State took to the streets at the weekend to protest what they described as the alleged persecution of a former governor of the state, Alhaji Yahaya Bello, by the Economic and Financial Crimes Commission.

Calling on President Bola Tinubu to call the EFCC to order, they insisted that the former governor had done more than any governor of the state for the people since its creation.

The women, led by various community leaders and party faithful, converged on the state capital, Lokoja, to condemn what they also described as a "witchhunt" by the EFCC.

They called on the President to urgently intervene in the matter by

ing the EFCC to allow the courts to do their jobs.

They argued that with the actions of the EFCC on Wednesday, it was clear that the agency's allegations against Bello were politically motivated and aimed at tarnishing his reputation, adding that they would not fold their arms and watch him lose his life.

"We stand with our leader, Yahaya Bello in this trying time. We believe he has been targeted unfairly and we demand justice. We won't watch him lose his life," one of the protesters, identified as Hajiya Halima Abass, said.

"The EFCC should focus on

genuine cases of corruption, not political vendetta," another protester, who simply identified herself as Mrs. Boluwaji, added.

The various women group leaders, who spoke in their local dialects – Igala, Ebira, Yoruba and others, urged the EFCC to be professional in its "handling of the case against the state leader, Alhaji Yahaya Bello."

They chanted songs, saying that Kogi people were fearless people and reiterated that they would not stand by and continue watching what they called a show of shame, especially after the former governor had made himself available to EFCC.

They wondered why the EFCC refused to interrogate or detain him while he was in their office but rather went shooting at night at the Kogi Government Lodge to arrest a man who had voluntarily

walked up to them earlier in the

day. "We Kogi people of Ebira descent cherish what our son, Yahaya Bello, did for us as governor. That is why we're out on the streets to ask EFCC to leave him alone.

"We are not giving him out to anyone to crucify. He will come back to us hale and hearty," one of the women leaders from Ebiraland, who simply identified herself as Hajiya Fatima, said.

"We, the Igala people from Kogi East, we are here because of our leader, Alhaji Yahaya Bello. He has never done anything bad to us. To those people that are looking to take him, please leave him alone. We have never seen this kind of government before. He did well for the state," another women leader who identified herself as Mrs. Deborah said.

The PDP members, as early as 8 am on Sunday, started the protest against the results of the local government elections released in the early hours of Sunday by KWASIEC.

The KWASIEC Chairman, Mohammed Baba-Okanla, in a statement made available to the press on Sunday morning, said that APC won the chairmanship and councillorship elections in the 16 local government areas and 193 wards of the state, respectively.

During the protest, a bonfire was made at strategic locations on Fate Road before they matched on to Zango/ Maraba Road to the General Post Office and Challenge areas of Ilorin Metropolis wielding placards with different inscriptions condemning the election results declared by KWASIEC.

The victim said that he was coming out of a shopping mall, where he went to buy something for his children on his motorcycle when he ran into the mob. •

Access Holdings grows revenue to N2.2trn in H1 2024

Access Holdings Plc, a leading global financial institution, has reported revenue growth to the tune of N2.2 trillion for the half-year audited financial period ended 30 June 2024.

Darkness hits Maiduguri as terrorists bomb newly repaired power Intervention of the synthesis of the synthes transmission line

arely three weeks after tit was restored, Boko Haram terrorists have reportedly destroyed Damaturu-Maiduguri 330 Kilovolt transmission line in Borno State.

Sources said the terrorists blew up the Transmission Company of Nigeria's infrastructure with improvised explosive devices in the early hours of Sunday.

The development had plunged Maiduguri and the surrounding environment into complete darkness.

"The attackers used improvised explosive devices (IEDs) to blow up the facility around 2 a.m., plunging Maiduguri and surrounding areas back into darkness. This marks a repeated targeting of the critical infrastructure by insurgents," the source said.

The incident comes weeks after TCN restored the line on September 4, 2024, following its earlier destruction by terrorists.

In a statement by Presidential spokesman, Bayo Onanuga, on Sunday, the President noted that one of the most effective tools available to law enforcement agencies is depriving criminals of the proceeds from their illicit activities.

The president strongly affirmed, "Nigeria is not a destination for stolen vehicles and a haven for illicit wealth from foreign countries."

President Tinubu affirmed that his administration remains committed to tackling money laundering, cybercrime, and other financial crimes.

Soldiers kill vandals, destroy 13 illegal refineries in Niger Delta

he 6 Division, Nigerian Army, says its operatives have neutralised two armed vandals involved in illegal oil bunkering during a gun duel and recovered two AK-47 rifles while 18 suspects were arrested across various states in the Niger Delta region.

Also, the Army said the troops destroyed 13 illegal refining sites, seven boats, uncovered eight illegal connection points and impounded over 60,000 litres of stolen products across the region.

"On getting to the scene, the criminal elements engaged troops in a firefight. In the gun duel that ensued, troops neutralised two of the criminals, recovered two AK-47 rifles, eight magazines and 69 rounds of 7.62 mm (Special) ammunition, while others fled in disarray. Efforts are ongoing to apprehend the fleeing suspects.

"At Bille in Degema LGA, troops deactivated four illegal refining sites, two wooden boats and handled over 6,000 litres of stolen products. Likewise at Odagba village, at the fringes of Imo River, troops intercepted two wooden boats with over 5,000 litres of stolen products, destroyed within the swampy area of Odagba village."

The statement further noted, "In Akwa Ibom, troops acting on credible intelligence intercepted six drums of premium motor spirit estimated to be 1,500 litres at Ibaka waterside in Mbo LGA.

"The products were being primed for onward smuggling to a neighbouring country through the waterways. All the persons arrested have been handed over to the prosecuting agency, while products confiscated are handled appropriately in compliance with subsisting mandates in the region."

The division's General Officer Commanding, Maj-Gen. Jamal Abdussalam, while commending troops for the successes recorded, reassured all that the division would continue to sustain ongoing operations across the Niger Delta region.

Citizens lament hardship in Nigeria, say it's becoming unbearable •Economic experts proffer quick fixes, maintain current economic policies will lead nowhere

igerians have expressed worry over their worsening predicament, saying the more they show understanding and make hard sacrifices in the face of the economic crisis, the harsher their living conditions become

They said about sixteen months after the removal of fuel subsidy by President Bola Tinubu, their woes have been compounded and that they are yet to experience any positive outcomes from the economic policies of the Federal Government.

Some of the nation's citizens who spoke with The Point in separate interviews queried President Tinubu who doubles as the Minister of Petroleum, Wale Edun, the Minister of Finance and Coordinating Minister of the Economy of Nigeria and Olayemi Cardoso, the Central Bank of Nigeria Governor on their economic policies which they said have been making life unbearable for the common man.

As the Naira continues to fall both in the Nigerian Autonomous Foreign Exchange Market, it is also declining in the parallel market, prices of goods and services in the country have been hitting the roof.

The Nigerian Economic Summit Group had said recently that the present economic situation in the country is scary.

Private sector led-think tank group said the country needs to take bold and decisive steps to address the challenges.

According to the chairman of the NESG, Niyi Yusuf at a news conference in Abuja, one of Nigeria's pressing concerns now is translating economic growth into improved lives and livelihoods for all its citizens.

Bemoaning difficulty in paying his children school fees for the 2024/2025 academic session, a father of three, Isaac Adelowokan said he did not know how he used the money he saved for his children's school

long are we going to endure this terrible situation? We are making sacinni rifices but nothing appears to be getting better. More taxes are being invoked by the government and prices of fuel are on increase almost on a daily basis. For how long should we sacrifice because we are tired? President Tinubu should act fast because things are already worse," Adelowokan, a tricycle rider in Osogbo said.

Another citizen, Mrs. Ige lamented hunger and financial distress across the country. saying the policies of President Tinubu have claimed

many lives and subjected several others into miseries.

She said, "When Ι say things are getting difficult, I mean it. We are losing people to this economic crisis and star-

> vation is everywhere. If you go to our hospitals, many are very sick and they are becoming hypertensive. The government is asking us to be patient but our public office holders appear not to know what we, the common masses are passing through. Asking us to make more sacrifices while the prices of things are increasing on a daily basis is tantamount to suicide and people

Federal Polytechnic, Ede, Dr. Oluyemi Omotosho-Junior, Avo Ologun and Prince Kanmi Ademiluyi called on President Tinubu to desist from "stepping on Nigerians' toes."

According to Omotosho-Junior, "President Tinubu asked us to sacrifice but he is creating more ministries and buying cars and yachts. He is here to enrich himself and members of his family.'

Lamenting the current economic realities, Ademiluyi stated, "The country is in an existential crisis. Cost of feeding and even paying school fees is scary. The President of a country is supposed to rally the populace and uplift the citizens." Speaking, economic experts argued that the current policies of the Federal Government would not ameliorate the suffering of Nigerians.

An economic expert, Oludare Mudashiru, called on the Federal and State Governments to focus on production and manufacturing in order to add value to Naira.

He said, "President Tinubu's policies upon assumption of office brought us to where we are at this unfavorable destination. Petrol was N200 when he became the President; a dollar was less than N740. Today, petrol is now over N1,000 and a dollar is over N1,600. What kind of economic policies would have brought us that far, it is a

very terrible economic policy." Questioning the rationale behind asking Nigerians to be more patient with the current economic policies when governments are increasing cost of governance and earning big, Mudashiru pointed out that, "If we are talking about delayed gratification that the President promised, then let us talk about delayed gratification across the strata. You cannot be talking about delayed gratification for the larger population and you are not delaying grati-

fication for the minutest population that is consuming the resources of the country.

"Delayed gratification is supposed to be across. The government should have cut its spending, it should have reduced their portfolio, should have reduced the cost of governance and that is what is delaying gratification. He should have used all of those cuts to expand the economy, grow the economy and then later, if they like, double the cost of governance. So, if you are talking about delayed gratification, how far can you ask Nigerians to be patient? For how long can you ask Nigerians to remain patient in the face of this suffering? Have the incomes of Nigerians grown within that same period? The price of fuel is growing from less than N200 to over N1000?'

that our own currency is not stumbling everyday against that benchmark currency. If you ask me, have Nigerians not been patient enough? Like I said before, a day will come when Nigerian leaders will realise that Nigerians should be applauded for being fantastic followers even in the light of their prevailing challenges.'

Emphasising on the need for trade and production to be prioritised by governments in the country, Mudashiru stated, "The relationship between currencies has to do with the purpose of the currency. Trade is a fundamental reason for means of exchange and the volume of trade you do is a determinant factor in considering how much comes to you is trading."

He added, "Foreign exchange is not just a function of sitting around the table and deciding how much of a particular currency you need as a country or how much of a particular currency you need as a country. What we should be talking about is if currencies are the means of exchange for goods and services, then, our fundamentals as a country is to produce those goods and services that will bring about the earnings of whatever currencies that we pretend to earn. And if the Nigerian currency is more important to us than other currencies, then we should do more of our trading in that particular currency. But, like I would always say, every country is supposed to always think about their comparative advantage. What puts us at advantage is when we now exploit the particular currency that we are looking for.

"It is a very simple rule of economics, the more goods you produce, the more services you render, the more the earnings you get and if you have become a country that has not been producing goods, that is not rendering services, then you will always be a deficit and that is what is happening to Nigeria and that is what we are battling as of today. It is all about production and service rendering that you are able CONTINUED ON PAGE 7

fees for the family upkeep.

"I am in a difficult situation now and I am losing it. Our Naira is miserable to the extent that when you have N200,000 in your savings, you discover you have nothing the moment you dip your hands in spending it. I had been saving for my children's school fees when they resume this September but look at me now, just in a matter of weeks, foods and other family needs have consumed it. My children are yet to resume school.

"Still, our President will ask us to be patient. The question is, for how

to get as much as you are determined or as much as you need as a country and for us, as at today, we are at our zero base considering our capacity, potential, natural resources, they are not close to getting us anywhere. You can see we are in a lot of debts right now."

Mudashiru argued that President Tinubu, Yemi Cardoso and Wale Edun have not been able to perform because they are using the style of which they deployed in governing Lagos State for Nigeria's economy.

"Lagos is a centre of trade and commerce, Lagos is not a centre of production, so, if you are bringing somebody who is used to selling things that he doesn't know how they are produced, they are just selling, then it will be difficult for the person to talk about production. Sometimes, they even sell reproduced goods and bring the same set of people to come and manage a system that is production oriented, it won't work.

"They are only bringing their rent seeking idea of which they ruled Lagos into governance. Having these Lagos guys at the helms of affairs has been the greatest challenge for Nigerians. They are putting the cart before the horse. We expect them to strengthen production first, add value and then trade and commercialise. We know that the oil and gas sector is the power in which this production is going to happen and if we are truly production centric, we won't just be hiking the price of energy. You have removed subsidies on everything in Nigeria and that is what we are suffering now," he stated

An economic expert, Paul Alaje, urged President Tinubu to start from scratch, saying, "The foundation has been destroyed and we need to start from the scratch. We need to fix the big elephant in the room and that is the exchange rate. Naira should weigh above N1, 000 to the dollar. And if we do that, the money going to the FAAC will reduce. But do the people in FAAC want their money reduced or do they want Nigeria to the manufacturing sector. From the recent report, service provided over 60 per cent. So, we need to focus on how we boost manufacturing and to boost manufacturing, you have to look at the cost of governance. If we don't reduce spending and reduce what is called Ways

and Means and keep it less than two percent, then we may not head anywhere," Alaje said.

A public affairs analyst, Ikenna Ofor, told The Point that he was skeptical about Tinubu's economic policies working as "advertised."

Ofor explained that it was so because policies of past governments in Nigeria did not address the country's economic challenges.

He also added that in Nigeria, preceding governments usually fare better than succeeding governments.

He said, "I understand that the President has been insisting that his economic policies will soon begin to bear fruits and that Nigerians will have reason to rejoice very soon.

"But I beg to differ. I am skeptical about the present administration's economic policies working as advertised. And this is because most of the economic policies that were implemented by past governments we have had in Nigeria have not rescued Nigerians from the brink. "Recently, there was a discussion on social media that centred on an unverified observation that in Nigeria, preceding governments always fared better than the governments that succeeded them. ment is expected to be better than Tinubu's government, but God forbid that it hap-

pens that way. "My prayer notwithstanding, I am still worried. The economic policies should by now have at least been showing early signs of recovery. The government sometimes says that prices are going down but, alas, in the markets and other places, prices of goods and services are still not reasonable and affordable for the common man."

About what more sacrifices Nigerians should make, Ofor advised, "About sacrifices Nigerians should make, I think the people have already made more than enough sacrifices. They have been paying for the little things they need way more than necessary.

"Salaries are no longer reliable and have remained static. They can't even be called takehome pay anymore. So, it will be wicked to ask Nigerians to make more sacrifices.

"Meanwhile, the only good thing Nigerians can do now is to ensure that they save more. If they can, the insignificant fees they pay to subscribe for cable television should be reviewed.

"Internet subscriptions should also be slashed. If you make N10, 000 subscriptions, for instance, you can cut it down to about N5, 000.

"And for those who love driving to work come rain, come shine, they should look at public transportation for now. It will go a long way in helping them to manage their depleted finances."

Meanwhile, Nigerians have again expressed frustration over the difficulties in accessing the Federal Government's N40, 000 subsidised rice launched on September 6, 2024, in Abuja.

"We started with civil and public servants because they possess the necessary credentials. Before purchasing, one must present a valid identity card and National Identification Number.

"Sales points were set up at the Office of the Head of Service of the Federation, Ministry of Agriculture, and the Independent Corrupt Practices Commission," the official, who spoke in confidence due to lack of authorisation to speak on the matter, explained.

He assured Nigerians that sales to the general public would begin on September 16, reiterating the government's commitment to ensuring everyone benefits from the initiative.

"Now that many civil servants have benefited, we are moving to the general public," the official added.

While the sales did begin as promised, citizens are lamenting the challenges of traveling from the outskirts of cities to urban centres, particularly in the Federal Capital Territory, to access the sales and collection points.

Many persons outside the FCT have reported being unable to locate any sales points at all.

In the Kubwa area of the FCT, a resident, Blessing Ameh, said, "Not at all. I have not seen any sales point in my area in Kubwa."

The situation was similar in Oyo State, where another resident, Deborah Johnson, remarked, "We have not seen even a single bag here."

Experts have suggested that for the initiative to be effective, the government must decentralise the payment and collection points, allowing people to purchase the rice without incurring additional transportation costs.

An agricultural economist at the Centre for Agricultural Development and Sustainable Environment, Federal University of Agriculture, Abeokuta, Tobi Awolope, said, "Accessibility is a crucial component of food security. Issues around the supply chain, particularly the high cost of transporting food, have posed a major threat to societal welfare, especially for rural dwellers.

"Access to food—both in terms of proximity and affordability—is a fundamental human right. Therefore, collection centers should be located where all social groups can easily reach them."

While Nigerians appreciate the government's efforts to alleviate the impact of rising food inflation, they are urging authorities to ensure that the rice distribution reaches areas where the majority of the population resides. A resident of Karu, Ibrahim Abdullahi, said "I was at the sales point located at the Nigerian Agricultural Insurance Corporation until the close of business vesterday (Thursday), but I couldn't make a payment due to the overwhelming crowd. "Today (Friday), I've been trying again, but to no avail. The government should decentralise the collection points so we can access the rice in our local areas."

Why I fell apart with Tinubu – Former Lagos deputy governor, Bucknor-Akerele

Senator Kofoworola Bucknor-Akerele, a former deputy governor of Lagos State, had represented the Lagos Central Senatorial District in the National Assembly between 1992 and 1993. In this interview, the lawyer, broadcaster and politician speaks on her years in politics, why she fell apart with President Tinubu, what she wants the Federal Government to do for Nigerians, among others. Excerpts:

How did you get into politics? How did you become the deputy governor to former Governor Bola Tinubu who is now the president?

Politics runs in my family. I came into politics because my father, too, was a politician. He contested on the platform of the Action Group and lost to the late Joseph Modupe Johnson (JMJ), but he and JMJ remained friends until their deaths.

In fact, my father's clinic on Apapa Road was in one of JMJ's houses. So, you see how the politics of that time was. My father encouraged me to go into politics. He felt that women were not represented enough.

You got along fine with Tinubu when he was governor of Lagos State and you were his deputy until things went sour between the two of you. How did the relationship get frosty?

We were on cordial terms at the start. When we were campaigning, all the food we were eating and everything was from my house in Victoria Island. So, as you said, it started okay. Where things went wrong was when Tinubu wanted to take over the Alliance for Democracy from the leaders and elders of the party. He wanted me to join him in the quest but I refused. That was when we fell apart.

I felt the leaders and elders of the party were the ones who supported us to get to where we were. They also were the founders of the party on whose platform we contested. I said it was wrong; that we should not plot to take over the party from them.

Have you spoken to Senator Tinubu since he assumed office as the president?

No, I haven't. I have no reason to speak to him. We are not in the same party; I am in the PDP and a member of the party's Board of Trustees. I have no reason to speak to him.

So, you two have not spoken to each other for a very long time? It's been several years.

complaining bitterly. What consolation would you offer the suffering citizens at this time?

Well, I don't know whether I would go for consolation. There is no consolation I can give them because I don't see any light at the end of the tunnel. The situation is bad. In fact, it is appalling. People cannot eat. Even I have to watch my finances now because there are so many people that I have to help. When my phone rings in the morning, it is somebody asking for financial assistance. When the situation is like this, it is really terrible.

I will give you an example: Yesterday, I had to buy some medicine for one of my relatives. I usually buy his medicine. Two weeks ago, the medicine cost N14, 000, but when I went to buy it yesterday, it was N20, 000. You see, the price of items goes up by the day.

Any day you go to the market, you find that the price of commodities has increased. The situation is really terrible and I don't think the government is trying hard enough to face the situation and make things better for the ordinary man.

The president has been asking Nigerians to be patient, that with his reform policies, things will soon change for the better in the country. What do you make of his policies?

I don't even know exactly what the policies are because he has not articulated them. All we know is that the fuel subsidy is gone. That's what he said and some people say that the subsidy is not gone. So, we really don't know what the true situation is in the country right now.

Still on the economy, a former Head of State, General Abdulsalami Abubakar said that palliatives are not the solution?

Yes, I agree with him. Palliative is not the answer. The answer is to make sure that people have jobs so that they can earn an income. The answer is that there should be security in the land so that people will not be afraid to invest in the country. That's the answer, not palliatives. We have to do something; we have to have a rethink, and then the reliance on crude oil should not be so. This country is blessed with so many mineral resources, so what is happening? Are we marketing our mineral resources? Those minerals should be bringing in money apart from crude oil, but it seems we are not doing anything about it.

We have gold. If you go to Beirut or Dubai, you will see people selling gold. They will ask you: which kind of gold do you want? Why can't we have gold stores in Kano, for instance, or in Sokoto? We are mining gold, what is happening to the gold? Why are we not having value added to it? Why are we not bringing people in to add value to our gold? We have other minerals, precious stones, what are we doing to develop the minerals?

taking over Lagos from the real indigenes. What is your take on this?

I am an indigenous Lagosian and, therefore, I feel very strongly about it because I think it is being purposely done. It is being purposely done that non-Lagosians should take over the most important positions from indigenes of Lagos State.

We started noticing it when Tinubu and I were in power. Let's face it. Whatever anybody says, Tinubu is not a Lagosian and I feel because of that, he wanted to put non-Lagosians in power to support him. I think he knew that with his background and antecedents, it would be difficult for him to do maneuvers in Lagos State and so he started promoting non-Lagosians into positions of power.

You obviously love Lagos so much, where do you want it to be in the next 10 years?

Lagos is a fantastic place, it is my hometown. And I have travelled to various parts of the world. In fact, I would say that there is hardly a continent that I have not been to.

When we look at places like Dubai, why can't Lagos be like that? When we look at places like Miami in the United States, why can't Lagos be like that? That is where I expect Lagos to be. That is where I expect those who are in positions of authority to be taking Lagos, not the shambles that Lagos is now, with heaps of rubbish and chaos virtually everywhere.

There is a popular belief that Tinubu was a strong performer when he was



governor of Lagos State. But under him as president, Nigerians have been groaning. What do you think is happening?

I don't know what he did in Lagos. Lagos has become a big slum. That is what I can see. He says he saved the Bar Beach or Victoria Island from being swallowed by the Atlantic Ocean, but all that he did was to push erosion further down the coast to Alpha Beach. What kind of saving is that? I cannot attribute any development in Lagos to him.

Let's talk about women. The clamour for stronger presence of women in politics has been on for some time. What advice would you give women as regards how to achieve this goal?

Well, I think a lot of women are deterred from going into politics because they fear violence which they think is associated with politics in Nigeria.

Is this phenomenon not present all over the world?

Definitely not. It is more prevalent in Nigeria and Africa. We saw the British election. We all watched it on television. People debated; they knocked on people's doors to campaign and I don't think there was violence. Even if there was violence, it is not tolerated. But here, we seem to actually condone it; we take it as if it is part of the system, and it should not be.

Of course, the financial aspect is also another thing because politics in Nigeria has become very expensive now. Most women don't have the financial strength to go into politics where you need millions of naira to be able to even contest to become a councilor. How many women have millions of naira at their disposal to be able to contest? This wasn't always so, but it became worse each time we had elections.

What then should women do to break this barrier and claim their place in governance?

Well, I will advise women not to be deterred. First of all, I think it is important that you are educated before you go into politics. If you are not educated, I don't think you can contribute much as a legislator or in any other capacity in the political terrain. I urge them not to be deterred. They should fight for more positions in the political parties. The problem really is that the political parties are male-dominated and because of this male domination, women are pushed aside; they are given the position of women leader. I believe that the position of the women leader should be cancelled in all political parties. Why don't they have the position of male leader? It just shows you the attitude of the political parties; they (the men) are not

Currently, it seems Nigerians are far from living a full and happy life, given the hyperinflation, rising cost of living, and the embarrassing chaos in the oil and gas industry.

President Bola Tinubu assumed office with a promise of renewed hope. Nigerians supported him, even after the unceremonious declaration at Eagles Square on May 29, 2023, and the subsequent call for patience.

Many questioned the rationale behind this call when the government showed no intent to reduce the cost of governance or stop the misuse of public funds on unnecessary activities.

Nigerians' patience wore thin by August 1, 2024, leading to nationwide protests. But that was just the beginning. The situation could worsen if the government does not address the confusion in the petroleum industry.

How can Nigerians pay over N1, 000 for fuel and still struggle to obtain it? In Tinubu's Nigeria, people spend hours queuing at filling stations and spend up to N50, 000 for fuel, only to find themselves back on the queue after two days. This is unsustainable and unacceptable.

Nigerians are deeply frustrated. They feel that nothing is working and do not believe the problem rests solely with the president. Many believe that most of the president's aides are either unfit for their roles or unwilling to perform them effectively.

Tinubu started by creating and renaming ministries, including appointing himself



as Minister of Petroleum - the largest cabinet in the country's history.

This is where the housecleaning should begin. The president needs to relieve himself of the role of Minister of Petroleum and appoint a competent individual to manage that role.

"I thank the cabinet members for their efforts, but I will relieve any of them of their duties anytime I feel that they are failing Nigerians," the President had said in May.

It seems the Tinubu cabinet is in a race to failure. The national grid has collapsed a record five times this year alone, supply remains erratic, projects from previous administrations are abandoned, more contracts are awarded, food insecurity and malnutrition persist despite agricultural initiatives, and security is nearly non-existent. The list of needed improvements is extensive.

Reshuffling the cabinet is necessary, and the President may need to start with himself as Minister of Petroleum. Presidents should focus on their strategic administrative roles and avoid holding ministerial positions.

The awkward norm began with former President Olusegun Obasanjo and continued with former President Muhammadu Buhari, and now, the current President, all due to the 'sensitivity' of the sectors.

Our petroleum industry is in disarray. The upstream sector, including exploration and pro-

duction, is plagued by oil theft, undermining our OPEC quota and attacking our revenue base.

The midstream sector, responsible for transportation and processing, is struggling with outdated facilities.

The shocks in the downstream sector are evident in the current fuel crisis across the country.

The Dangote Refinery, touted as a definitive solution to the country's energy crisis, has been plagued by countervailing forces.

Ending the subsidy regime had potential benefits, but the increased federal allocation to states has left many more confused. The dividends have not trickled down to the common man.

The problem is immense and seems too great for a President who also chairs the Economic Community of West African States.

Mr. President should exit from the role and appoint an excellent technocrat to handle the petroleum sector comprehensively. Obviously, there is a lot on the table of the president. Nigeria's economy requires his full attention.

As commander-in-chief of the armed forces of Nigeria, he needs to be on the driver's seat to tackle the hydra-headed insecurity, banditry, terrorism and criminality in the country. Terrorists and bandits have grown bold, attacking monarchs and publicising their acts on social media.

Nigeria's infrastructure is largely comatose. Hunger pervades the land, the Food and Agricultural Organization reports that over 26.5 million people are experiencing acute hunger this year, with predictions that between 82 million will face severe food insecurity by 2030.

The only way out of this stalemate is for the President to take decisive action against non-performing ministers, aides, and heads of agencies, starting with stepping down as Minister of Petroleum.

The floods that periodically sweep across the banks of Rivers Benue and Niger down to the Atlantic Ocean in Bayelsa State emanate from the Lagdo Lake in Northern Cameroon.

This occurs seasonally, whenever excess water is released from the lake to protect the dam from bursting, inundating, and overwhelming the surrounding towns and villages.

The Lagdo Dam was built in 1982 by a Chinese company to provide electricity and potable water and irrigate farmlands in Garoua and the northern provinces of Cameroon.

The flood flashes experienced in Nigeria today were expected to happen; hence, in 1982, a feasibility study was conducted to build a water withholding dam at Dasin Hausa in Furore Local Government Area of Adamawa State.

Unfortunately, this project did not proceed further, and after over

dam when I accompanied officers from the Nigerian Institute of Policy and Strategic Studies, Kuru, during their 1992 world tour, and my mission, the Nigerian High Commission, Yaounde, hosted the group. The government of Cameroon organised a guided tour of the dam complex for the delegation.

The lake is the source of potable water and irrigation of cotton, maize, millet, and sorghum animal food, grazing fields, and fishing in and around Garoua. The electricity generated powers the Northern provinces of the country with excess capacity.

Cotton produced is processed into clothing materials in textile mills in Garoua, where there is a river port through which goods are transported in barges on the River Benue tributary to Douala seaport over 1000 kilometres away. The funds for the completion of the dams should be sourced from Nigeria's foreign reserves, which remain strong at over \$40 billion. This should start the Dasin Hausa and other flood-control dams. The insights gleaned from the book highlighted the lost opportunity to safeguard lives from deaths and loss of properties by building dams and irrigation units.

The loan option is another possibility, in which case the funds obtained cannot be used for any other purpose other than the designated projects.

This will create unnecessary delays because the 'investors', in most cases, do not have the funds or anything to offer other than influence in high places.

In conclusion, the root causes of the flash floods in Nigeria are known, and the solution and sources of funding have been identified.

three decades of dilly-dallying, the plan is still on the drawing board.

The dam in Nigeria would have stopped the incessant floods along the banks of the Benue River and further downstream to the sea. It would in addition, generate electricity, irrigate at least 150,000 hectares of farmlands, create jobs, and attract tourists to the location and Adamawa State.

Also, the oil for the project solution should be emplaced as a viable option. This is also called countertrade, a situation where oil wells in exchange for capital projects is another option.

Government should defeat hunger in Nigeria

he latest data from the National Bureau of Statistics showed that Nigeria's headline inflation rate decreased to 32.15 per cent in August 2024 despite the recent hikes in the pump prices of petrol nationwide. This figure represents a 1.25 percentage decrease from the 33.4 per cent recorded in July 2024 and the second consecutive monthly slowdown in inflation after a persistent rise in nearly two years.

The NBS in its Consumer Price Index report said the drop also signaled a slower pace in the increase of the average price level compared to the previous month.

For far too long, Nigerians have been under torment by the astronomical rise in the prices of basic foods and services in the marketplace. This gives room for a huge concern as the steep prices have battered the purchasing power of citizens, leading to uncertainty, an increase in poverty, and an unpalatable cost of living.

With food as a primary resource for human survival, the disruption caused by rising food inflation has further decimated their low wages.

At 87 million people, the World Bank said Nigeria's poverty rate hit 38.9 in 2023. This is the second highest in the world behind India's. A 2022 survey by the NBS said 133 million Nigerians are living in multidimensional poverty.

The 2023 Global Hunger Index said that Nigeria's hunger level is "serious." Nigeria ranks 109 out of 125 countries with a score of 28.3 per cent in the hunger index. This is a dismal outlook that should be improved on by the government at the grassroots, state, and federal levels.

High energy prices constitute another shambles. When the raw food finally arrives, citizens face another harsh reality to cook it.

Nigerians are feeling the strain as the cost of refilling cooking gas continues to rise, putting additional pressure on household finances. According to the latest data for July 2024, the average price of a 12.5kg cylinder of cooking gas has climbed to N14, 287.

Despite being a major oil-producing country, Nigeria still relies heavily on imports for its LPG supply.

The current foreign exchange challenges have made it increasingly difficult for importers to access the necessary funds, leading to higher costs for consumers.

The situation is very unfortunate. Prices are going higher, and Nigerian consumers are going through very difficult times because they can no longer afford gas and are now resorting to firewood, charcoal, and sawdust for cooking.

The Minister of Solid Minerals Development, Dele Alake, disclosed recently that President Bola Tinubu gave each of his ministers 1,200 bags of rice for distribution as pa

sarawa, Kaduna, Katsina, and Borno, where violence plagues the states often regarded as Nigeria's food belt.

In Niger, Kaduna, Katsina, Zamfara, and other states, bandits and terrorists hold sway, collecting levies or tributes from farmers before they can plant or harvest their crops.

SBM Intelligence said 2,134 persons were killed in the first quarter of 2024 under President Bola Tinubu. In December, about 150 villagers were massacred by bandits in Bokkos and Barkin Ladi local government areas in Plateau State during the Christmas festivities.

Resembling an annual ritual, Boko Haram Islamists beheaded 15 rice farmers harvesting the crop in Borno State last November. In November 2020, the Islamists had similarly beheaded 76 rice farmers in Zabarmari in the same state.

Unfortunately, the situation is compounded by poor rural roads across the country. Out of its 200,000km road network, 87 per cent is in a deplorable condition, according to the World Bank

> In contrast, India built 300,000km of roads between 2000 and 2010, thereby reducing farm losses from 80 to 20 per cent and encouraging citizens to return home to farm.

The roads are a death trap, leading to farm losses and a bulwark to the movement of food and raw materials in the country. The state governments should stop making excuses for this; they should prioritise the development of rural roads to ease the agriculture business

They must tackle the menace of 'nuisance taxes' on the roads. These taxes, collected by amorphous non-state actors, hinder the evacuation of produce

and add to the final prices of food items.

The Federal Government, which had earlier stated that it would collaborate with states to reduce the number of taxes from over 80 taxes to nine, should unveil its plans on this quickly.

To ensure food security, Tinubu and his National Security Adviser, Nuhu Ribadu, the police, and other security agencies, must be in the driver's seat of Nigeria's security architecture.

Urgently, intelligence garnering, coordination, and technology must be deployed to combat the ugly descent into anarchy.

This calls for the urgent establishment of state police across the country. It will go a long way to place proactive measures to combat crime while quickly responding to vicious attacks on farmers and citizens. State governments and the federal and state parliaments should invoke the 'doctrine of necessity' to realise state police.

With its high population - estimated at 223 million - Nigeria needs a robust agriculture system to feed the populace. Therefore, it must develop infrastructure to hold excess rainwater for dry-season farming.

The government at the three tiers should support farmers with accountable and transparent incentives while encouraging farming by enabling farmers to secure mechanised farming tools in farm clusters. Low-interest loans should be made available to participants in these clusters.

According to him, his own bags will be given to the aged in his state.

The Lagos State Government commenced Phase II of its 'Ounje Eko' Food Discount Market on September 1.

These interventions help but only scratch the surface. First, without adequate security, Nigeria cannot have food sustainability. The country is grappling with banditry, wanton killings, kidnapping, criminality, Islamic terrorism, and violent Fulani herdsmen attacks on farmers.

Consequently, farmers have abandoned their farmland for fear of bandits and herdsmen, thereby contributing to food shortages across the country.

In March, the Cocoa and Plantain Farmers Association of Nigeria said that despite the presence of security operatives, many farmers have abandoned their farmland due to incessant killing, kidnapping, and destruction of farms.

The situation is rampant in Benue, Plateau, Adamawa, Na-

The Presidential Livestock Reforms Implementation Committee co-headed by Professor Attahiru Jega has recommended the adoption of both ranching and open grazing, at least in the short term, to halt the recurring clashes between farmers and pastoralists across the country.

According to Jega, abandoning pastoralism abruptly for ranching without consideration for those huge populations who have their lives built around the system would not be advisable. Nigeria should explore efficient and successful agriculture models within and outside the continent to reduce its high food inflation.

The government at every level should undertake tangible programmes to defeat hunger in the land.

Nigerian surrogate mothers narrate gains, pains of carrying pregnancies for fellow women

ver since 34-year-old woman, Grace Edema parted ways with her husband, she has been battling a great challenge in fending for the two children she had for her estranged husband.

Grace said she was a salary earner and was making people's hair but the money she realised in the businesses was not enough to take care of herself and her two children.

She explained how she got introduced to the surrogacy business, saying she accepted the offer after meeting the requirements because "I am tired of suffering.' At a time the economy of Nigeria is severely challenged, some citizens have been striving hard to beat the hardship. Grace recalled how her transportation fare to work in a month was almost the same amount she was earning as salary, hence her decision to quit the job. She said poverty forced her into carrying pregnancies for fellow women.

delivered of her second child, her husband abandoned her and it has been difficult for her to fend for herself and her two children. Hence, she became a surrogate mother in order to keep body and soul together and meet other extended family needs.

Grace was one of the surrogate mothers who revealed the intrigues in the so-called business of surrogacy during their separate interviews recently.

They said aside from being a means of putting food on their table, surrogacy also avails them the opportunity of solving couples' childbearing challenges not minding the painful experience.

Checks by The Point revealed that some surrogacy agencies recruit women who are interested in becoming surrogate mothers and after meeting the criteria set by intending parents such as height, weight, complexion, beauty and so on, the egg of the intending parents are inserted into the surrogate mothers following series of medical tests.

It was gathered that intending parents or individual women who seek the services of surrogate mothers pay the latter huge amounts of money for carrying their pregnancies and giving birth to their children for them.

"I must confess that this surro-

This is why I decided to undertake surrogacy because aside from the money I get there, it is an opportunity for me to put smiles on the faces of those seeking to have children of their own," she explained.

Another surrogate mother, simply identified as Ramota, said it was the need to cater for the needs of her mother, siblings and child that provoked her interest in the endeavour.

According to her, her father gave birth to 24 children but the man did not take care of them. She revealed that it was the various mothers of her siblings that took the responsibilities for their upkeep. "I am determined to end the kind of poverty that my mother is facing. So, when the surrogacy business came, I had to grab it," Ramota stated. ested women. But, my mother and my immediate elder sister know I am a surrogate mother.

"I am pleased with the job and I am better off than when I was a salary earner, making hair for people and doing house maids. I never made the gains I am making now as a surrogate mother in my previous works," the mother of two added.

Also, Ramota believed that being a surrogate mother is better than going into crime or prostitution.

The founder of a surrogate agency, Meet Surrogate Mothers, Olaronke Thaddeus, said they keep surrogate mothers in their care for weeks so that they would not have sexual intercourse with any man that may impregnate them and discard the egg planted into them. She said it was during the period that surrogate mothers get sensitised and also sign necessary papers to formalise the deal. According to her, the process, including the tests to be carried out on the intended surrogate mother, is tedious while the In vitro fertilisation, popularly known as IVF, is "very painful."

According to her, after she was

It is the joy of most women, especially the married ones to have their own babies after the wedding ceremony. However, in some cases, some couples battle childbearing delay and other fertility challenges. Some even don't want to go through the rigour of pregnancy, preferring other women to carry their pregnancies and give birth to their children for them. Others who may not want to adopt children are embracing surrogacy. gacy thing is not easy. The insertion process is very painful. But, I am tired of suffering and I can't watch my mother and siblings go hungry, that is why I decided to be a surrogate mother," Grace said.

She explained further how hardship made her realise the economic potentials in assisting her fellow women carry pregnancies and give birth to their children.

"God gave me children but I can't even feed them well not to talk of raising them properly.

For Grace, only her elder sister and mother know she is into surrogate business.

"I have to make mine a secret because many of my friends won't believe I can become a surrogate mother. Their thinking is that one becomes pregnant and sells babies to inter-

How, when next Owa Obokun of Ijesaland will emerge - Chief priest

•Says rams, not human beings, used for Oba Aromolaran's burial

he Chief Priest of Ijesaland, Ifagbemiga Ajilore, has denied speculations that the late Owa Obokun of Ijesaland, Oba Gabriel Adekunle Aromolaran, was buried with human beings.

According to the Baba Awo of Ijesaland, the rumour that some persons were caught during Oro festival that took place in Ilesa recently is baseless and lacks truth.

Chiefs in Ijesaland had declared a seven days curfew for funeral rites of the deceased frontline monarch across the towns affected.

During the curfew period, the Oro festival took place last week. Traditional priests who wore white clothes and walked about empty streets of Ilesa were seen chanting some dirges and making some incantations.

Shortly after movement resumed in the ancient town, rumour started flying that some non-indigenes were abducted for some rituals and burial of the late monarch.

Debunking the insinuation in an interview, Ajilore, who is also the Asiwaju Awo of Ijesaland, claimed no one had ever been buried with a late king and that only rams were used for the burial of Oba Aromolaran.

He said the whole rams in Ilesa were

bought for the rituals and that when the town ran out of stock, some people were sent to Osogbo, capital of the state, to purchase more rams for the rites.

An Ifa High Priest, Ifayemi Elebuibon, had said rituals traditionalists perform after demise of Oba are not usually for the dead monarchs, he said they are for the safety of the family and the next Oba because the one that has passed on has gone to be with his ancestors, adding that, "the only prayer they offer for the dead is for them to have a good passage to heaven. Other rituals are for the new Oba and the family so that there won't be deaths in quick succession. They are done so that the successors of the late monarch won't be dying prematurely, one after the other. That is why they perform the rituals."

Ajilore insisted that no human parts were used for the burial rituals of Oba Aromolaran, saying, "We also heard the rumour and I want to tell you that it is not true. Some people talk carelessly so that people can say they know what is going on in the town while others do that to tarnish the image of our tradition and its adherents. Some people have been announcing on social media that strangers should not walk about in Ijesaland and that strangers are used to bury Owa.

"I am assuring everyone that there is

nothing like that. Since we conducted the Oro rites for our royal father, how many people have been declared missing in Ijesaland? So, it is not true that we make use of human beings to bury our kings. All that we have been doing is in the full glare of security operatives in the state. Those making rumours are doing that to gain attention and to cause tension. There is peace in Ijesaland and no one has been used. We have been doing the rites peacefully. I challenge the person making the rumour to come out in public and say it and tell us the person we allegedly used. The person saying such things deserves to be cursed."

On the items used for rites on the late traditional ruler, the chief priest said, "We only used rams. In fact, we bought all the rams in Ilesa and later went to Osogbo to buy more. If we used human beings, shouldn't they have declared people missing? Those making this rumour might be Ilesa cultists who have been killing themselves to count scores and they might have been causing this tension in order to kill themselves more. No one should use this incident to commit any crime."

The chief priest explained the reason why curfew was declared for the Oro rituals, saying, "Obanla of Ijesa led the Oro ceremony to wipe out evils that may arise in Ijesaland. If we didn't declare a curfew, motorists and motorcycle riders would have rammed into participants of the festival but due to the curfew, everything went well."

On how and when Oba Aromolaran's successor will emerge, he said the selection process would kick start after final burial rites of the monarch, disclosing that the Ifa oracle would choose a new Owa Obokun of Ijesaland and not the government.

"We believe that Ifa will choose a good king for us. It is our hope to have a good monarch that will lead well. Ifa is still active and reckoned with in Ijesaland. Some Obas saying rubbish about our tradition are those who were not chosen by Ifa in the first place. Those denigrating our culture were not chosen by Ifa. Some Obas identifying with other religions have lost it. I have consulted Ifa for many towns and it chose their kings, our own in Ijesaland won't be different.

"It is Ifa that will pick the next Owa of Ijesaland and not the governor or money. The funeral ceremony of our Kabiyesi will happen soon and it will be announced in the media. We should expect it.

"In choosing our next king, I assure you that royal families won't have a problem. It is after the funeral ceremony that we can go into selection of a successor. There are families that will produce candidates. Once If a picks and people say otherwise, then it is left for them," Ajilore declared.

The aview to continue to fulfill its constitutional mandate, the Nigerian Security and Civil Defence Corps, Ebonyi State Command, has requested the intervention of governments, philanthropists and cooperative bodies in the areas of provision of some operational equipment.

He said the command recorded 40 cases of vandalism of public facilities in Ebonyi State between January and June this year.


Out of the 40 cases, he said the command was able to secure the conviction of two persons while others are still pending in various courts of competent jurisdictions.

"Upon contacting the mother, one Peace Adegboyega 'f', she stated that her daughter had died from electrocution on September 19, 2024, at about 10:20 am, and arrangements were being made for her burial the following day.

"She expressed shock upon learning that their neighbour, Ogidan, was found with the amputated body of her daughter in the bush."

Odutola added that upon further search of the suspect's house, ammunition and local charms were recovered while he allegedly confessed during interrogation that the father of the deceased teenager had contacted him to assist with the burial.

The state PPRO added that three other suspects who assisted in the digging of the grave were also arrested.

"A search warrant was executed at Ogidan Mustapha's residence by the Divisional Police Officer and the Vigi-

mand.

He mentioned insufficient operational vehicles, diesel, Information Communication Technology gadgets as some of the challenges facing the command in the line of fulfilling its core mandates in the state.

"Some of the challenges we are facing in Ebonyi command is lack of operational vehicles and diesel for quick response/surveillance, ICT gadgets for digital security among others," he disclosed.

Notwithstanding the challenges, the commandant noted that NSCDC under his watch has recorded severwell as protection of lives and property.

Odutola noted that some officers of the Vigilante group had noticed suspicious activities around the bush around 1:30 am which prompted them to search the area.

She added that the search led to Mustapha's arrest with the corpse of the teenager wrapped in a mat with both hands amputated.

The PPRO said, "Upon closer inspection by vigilante operatives, it was discovered that the corpse was a young girl, one Oriyomi Gboyega 'f' 13-yearold with both of her hands amputated lante group. Two English pump action rifles and various local charms were recovered in his house.

"During police interrogation and questioning, the suspect denied amputating the 13-year-old girl but confessed that the girl's father, one Sunday Adegboyega, had asked him to help bury the deceased far from home.

"Three other suspects of northern origin who assisted in digging the grave were also arrested."

Odutola noted that the case had been transferred to the command's Criminal Investigation Department for onward investigation.

Some irate youths of Solo Street, Jyekhei Heritage Zone of Auchi town in Edo State have reportedly lynched a young man simply identified as Omoh for allegedly killing his elder brother, Rasheed Braimah.

Braimah was, before his tragic death last Friday, a lecturer at the Department of Accounting, Auchi Polytechnic.

Omoh allegedly attacked and killed his brother days after returning to Nigeria from Libya. The duo were said to be members of the Osigwe family of Iyekhei Heritage.

However, witnesses gave different accounts of how the siblings died and what led to their deaths.

The Point gathered that Braimah was at Auchi burial ground for the burial of their aunt when Omoh, his younger brother phoned him and asked him to come and meet him somewhere, claiming he wanted to show him something.

Braimah reportedly left the burial ground to meet Omoh and that was how the Libya returnee shot him and ran away.

Youths of the community got wind of the incident and searched for Omoh, brought him to the spothe shot his brother and burnt him to ashes.

"They are three boys of the same parents. One is aboard but in prison and that was one of their misunderstandings. Omoh claimed that his elder brother, Rasheed, was not doing anything to release their brother. He went to native doctor and he was told that Rasheed is progressing because he used their destiny. That was how the family lost two young men in a space of hours," a witness said.

Another source corroborated the witness'

claim saying Omoh is a twin and wanted Braimah to help facilitate an exercise that he thought would get his twin brother identified as Odion out of jail in Europe but owing to the uncooperative tendencies of Braimah, Omoh decided to end the lecturer's life.

Meanwhile, some other sources said Braimah sold the only land their late father left for them and gave a paltry amount to Omoh.

"Rasheed sold their family land and used the money and gave them peanuts. Omoh is a very nice boy. He just came back from Libya and Rasheed could not even settle him with his own share of money to start life.

"When Omoh was brought back from Libya last month, he travelled to Auchi so he could get something from his brother. All he got was a peanut. Omoh just wants to get his



money from their dad's land that Rasheed sold. My problem is where he even got the gun because if you know Omoh, you will understand he is a humble person. One of their family members is my best friend

here in Europe.

"The truth is that their family has a problem. Their parents died the same day. Even their sister, Abrome's death was questionable. Also, their uncle, Apakava's death was something else. They went to bury their aunt that just died and ended up dying the same day. The family lost three souls in a day," a source identified as Chika said.

Experts seek concerted efforts to avert looming health risks in flood ravaged Nigerian states

Health and sanitation experts have called for intensified efforts by concerned stakeholders to avert possible disease outbreaks in states battling flood challenges.

According to them, if Water, Sanitation and Hygiene (WASH) issues are not prioritized immediately in Maiduguri, Borno State capital and its environs that were recently ravaged by devastating flood, residents might have to be inflicted with deadly diseases.

Already, Borno State is one of the states in Nigeria that still contend with the issue of open defecation.

Experts noted that it was possible for the recent flood to have swept human faeces and urine into the body systems of the survivors of the disaster of which if they are not quickly treated, they may be struck with Neglected Tropical Diseases.

A World Health Organisation report on NTDs had shown that Nigeria and 15 other countries have the highest burdens of the diseases. NTDs are a diverse group of 20 conditions that are mainly prevalent in tropical areas, where they affect more than one billion people who live in impoverished communities.

The diseases are caused by a variety of pathogens, including viruses, bacteria, parasites, fungi, and toxins.

Aside from the fact that the flood has displaced residents, killed some and also destroyed property, experts said there are health risks such as water borne diseases and sanitation crises that should be given emergency attention to prevent more loss of lives in affected areas.

Even though the Federal Government had warned Borno residents to apply cautionary measures, as drinking water may be contaminated, a Sanitation and Hygiene Manager for Water Aid Nigeria, Dare Oduluyi told The Point in an interview that the Federal and Borno State Governments should do more than warning in securing the lives of the people.

At a press briefing in Abuja last week, the Minister of Water Resources and Sanitation, Prof. Joseph Utsev said that while the Federal Government sympathised with the Borno State government and the displaced residents, it was important to inform people on the need to beware of their source of drinking water.

Utsev stated that there is a possibility of an outbreak of waterborne diseases following the devastating flooding.

He said, "It should be noted however, that as we try to recover from this disaster, the water we drink may CONTINUED ON PAGE 15



NDLEA intercepts N16.1bn opioids, arrests octogenarian, community leader's wives, son •Iran-bound drug mule excretes 76 wraps of cocaine at Kano airport

peratives of the National Drug Law Enforcement Agency have intercepted a total of N25 million pills of tapentadol, an opioid three times stronger than tramadol and 350,000 bottles of codeine-based syrup at the Tincan port complex in Lagos.

NDLEA spokesman, Femi Babafemi, said in a statement on Sunday that the seizures were made on Tuesday 17 and Friday 20 September 2024 from three containers which had been on the watch list of the Agency following processed intelligence.

As a result, he said the NDLEA had requested for 100% joint examination of the shipments with men of the Nigeria Customs Service and other security agencies.

The N25 million pills of tapentadol have an estimated street value of N13.725 billion while the codeine consignment has an estimated street value of N2.450 million, bringing the total value of the seizures to N16.175 billion.

The tapentadol consignment packed in 500 cartons was discovered in one of the containers on Tuesday 17th September while another container examined the same day contained 175,000 bottles of Barcadin cough syrup with codeine packed in 875 cartons.

Babafemi said the third container containing 175,000 bottles of CSC cough syrup with codeine was examined on Friday 20th September.

Meanwhile, he added that operatives of the Lagos State Strategic Command of the Agency on Friday 20th September arrested an 80-year-old grandfather, Aremu Shojobi with 14 kilograms of cannabis at his home in Iyana Ipaja area of the state.

In his statement, Babafemi said the octogenarian claimed he has been in the business of selling illicit drugs for 25 years. He further claimed he gets his supplies from the Benin Republic, and sells to his customers from his residence between 7am and 10pm every day.

In the same vein, he said NDLEA

Babafemi explained further that a total of 451 blocks of cannabis weighing 213kg were intercepted along Azikiwe road, Port Harcourt, Rivers state on Wednesday 18th September, by NDLEA officers who apprehended a suspect Ogochukwu Paul, 33, conveying the consignment to a notorious drug haven in Borikiri.

be contaminated, we should please be mindful of this, so as to avoid further outbreak of waterborne and communicable diseases."

But, Oduluyi said residents of Borno are also threatened by the sanitation crisis because the flood has washed some toilets away, a situation that may worsen the open defecation practice in the state.

"Though a lot of emergency response is happening in Borno, sanitation matters should be given priority. We have been talking about water

tunity to run somewhere or hide but for water, you can't. So, the effect is enormous.

"In Borno State now, they have closed down the schools for the next two weeks. That is one significant effect. Students will miss those periods and the entire country will not wait for them. The uniform examination they do will not wait for them because they have flood that is already a loss for them. When they resume, they will either rush or just skip those parts.

"Another thing that we have to look at is life and property.

People are dead and properties have been destroyed, houses and cars have been submerged. The water from Alau Dam is not the kind that could enter a car engine and the engine will work well again. Reacting to the disaster, A WASH specialist with United Nations Children's Fund, Chioma Adimorah, said UNICEF is supporting the Federal Ministry of Water Resources in building toilets to the displaced residents in Internally Displaced Camps in the state with a view to tackling the impending sanitation and hygiene crisis. She said two IDP camps have been established and more would be constructed, adding that there is a committee for cholera outbreak in place. The specialist disclosed that efforts are on for disinfection of contaminated water.

APC's Okpebholo wins Edo governorship election

PDP, governors kick, insist Ighodalo won, petition INEC chair

fter months of intense politicking in Edo State, the Independent National Electoral Commission Lon Sunday night declared Monday Okpebholo of the All Progressives Congress as the winner of the keenly contested Saturday 21, 2024 governorship election in the state.

Okpebholo secured 291,667 votes to defeat Asue Ighodalo of the People's Democratic Party who got 247,274 votes and Olumide Akpata of the Labour Party who came a distant third in the race with 22.761 votes

Fourteen other candidates contested the seat but got less than the three frontline candidates.

"That Okpebholo Monday of APC having satisfied the requirement of the law is hereby declared the winner and is returned elected," INEC's Returning Officer for the poll, Prof Faruk Kuta, said at exactly 09:27 pm, to delightful cheers from APC supporters at the collation centre in Benin City, the state capital on Sunday.

Kuta, the Vice-Chancellor of the Federal University of Technology, Minna, in Niger State, declared the winner of the poll after a series of recesses

The APC candidate cleared over 10 of the 18 local government areas, leaving the PDP candidate with marginal victory in the other local councils.

The APC gained control in two of the three battleground senatorial districts in the state

Okpebholo, the Edo Central Senator, leveraged significant influence in his senatorial district, and joined forces with his colleague in the National Assembly from Edo North, Adams Oshiomhole, to defeat Ighodalo, the anointed candidate of the outgoing governor.

Ŏkpebĥolo's victory could also be attributed to his alliance with Dennis Idahosa, his running mate who is a federal lawmaker; and Obaseki's estranged deputy, Philip Shaibu.

tre, which was heavily guarded for the collation exercise.

Governor Obaseki had earlier stormed the collation centre to protest the exclusion of PDP agents from the venue but was escorted out of the premises by armed security agents.

At the collation centre, PDP agent, Tony Iyoha, called for the suspension of the entire election over alleged irregularities.

Similarly, the party's chairman in the state, Anthony Aziegbemi, explained that the discrepancies between figures on the EC8 form don't tally with those on INEC's IReV platform. The PDP Governors' Forum also asked the electoral umpire to respect the will of the people of Edo State and let their votes count. The Forum alleged that the exercise was fraught with electoral malpractices. The PDP governors led to Edo by Adamawa State Governor, Ahmadu Fintiri,

to litigations and court judgements. Others are Anambra, Bayelsa, Ekiti, Imo, Kogi, Osun and Ondo.

PDP, GOVERNORS BACK FINTIRI, INSIST IGHODALO WON

However, the People's Democratic Party and its Governors Forum have expressed support for the Chairman of the Edo State Governorship Election National Campaign Council, Adamawa State Governor, Ahmadu Fintiri, who stated that the PDP candidate, Asue Ighodalo, clearly won the state governorship election.

On Sunday, Fintiri stated that the Independent National Electoral Commission should be held accountable for violating the Electoral Act.

In a statement on Sunday, the National Publicity Secretary, Debo Ologunagba, responded by explaining that Fintiri presented results from the polling units showing Ighodalo in a clear lead.

Ologunagba claimed that this was before the state collation exercise being taken over by the APC, which allegedly conspired with some dishonest INEC and security officials to alter and replace the authentic results with falsified figures favouring the defeated APC candidate.

The statement read, "The People's Democratic Party stands by the results of the Edo State governorship election as garnered by its polling agents across the state and echoed by the Chairman of the Edo PDP National Campaign Council, Governor Ahmadu Fintiri of Adamawa State which indicate that the PDP candidate, Dr. Asue Ighodalo, clearly won the election.

"The PDP asserts that the rush, venom and hauling of insults with which the All Progressives Congress attacked Governor Fintiri only confirms APC's violent desperation to cover its manipulations and steal the mandate freely given to Dr. Asue Ighodalo by the people of Edo State as reflected in the genuine votes cast at the Polling Units.

"As Governor Fintiri presented, the results collated from the Polling Units have Asue Ighodalo in clear lead before the state collation exercise was hijacked by the APC which, in connivance of some unscrupulous INEC and security officials, engaged in blatant alteration and substitution of the genuine results with fabricated figures in favour of the defeated APC candidate. "The PDP had on several occasions alerted Nigerians of this sinister plot by the APC which will be firmly resisted as the APC and its candidate Monday Okpebholo were thoroughly defeated in the election." The PDP spokesman warned that any attempt to alter the results of the governorship election and award victory to a defeated candidate will lead to serious

The declaration on Sunday evening brought Okpebholo closer to achieving his goal of becoming governor of the state and placed his party, the APC, on the cusp of a return to power at the Dennis Osadebe Government House.

The APC lost power in the state in 2020 after the incumbent, Godwin Obaseki, defected from the party to the PDP in the heat of an intra-party squabble and fallout with his predecessor, Oshiomhole.

Âfter he was denied the APC governorship ticket, Obaseki joined the PDP and clinched the ticket to defeat APC's Osagie Ize-Iyamu to seal his second term which will end on November 12, 2024.

Obaseki campaigned strongly for Ighodalo, while Oshiomhole was a focal

figure for Okpebholo's campaign, attending rallies and interviews on behalf of the APC candidate.

Okpebholo was declared winner of Saturday's election amid protests by supporters of the PDP who strongly posited that the results were fabricated and did not represent the will of the people.

There were protests in parts of the state capital and outside the INEC collation cenfaulted some of the results announced, saying they don't tally with those on IReV.

According to INEC, 2,249,780 persons with Permanent Voters' Cards decided Obaseki's successor on Saturday, September 21, 2024.

Edo is one of the eight states where governorship elections are held off-season due

repercussions.

The statement added, "The PDP in the strongest terms cautions the APC and INEC not to announce or declare any result that does not reflect the will of the people as expressed at the Polling Units. Such will be a recipe for a huge crisis in the state as the people of Edo State will never allow their mandate in illegitimate hands.

"While for the PDP, a collation of the votes from the results uploaded on the IREV is 18,620 but 15,865 was returned on the EC8C declared by the LGA Returning Officer.

"It would interest you that in Ward 9 Akoko Edo LGA, from the 36 Polling Unit results uploaded on the IREV, the total votes obtained by APC is 2,350 while 9104 was entered into the EC8B result for APC. The total votes for PDP is 1,359 while 633 was entered in the EC8B.

"Also, in Ward 6 Akoko Edo LGA, where elections did not hold in Ward 6 Units 12, 17, 15, 18, 14 and 16, results were returned for the said polling units in the Ward Result sheet (EC8B)."

He went further to explain that a simple collation of all the votes recorded in the polling unit results uploaded on the IREV shows that the APC obtained 10,972 votes while 16,760 votes were instead recorded in the EC8C declared by the LGA Returning Officer.

He said, "While for the PDP, a collation of the votes from the results uploaded on the IREV's 14,485 but 14,658 was returned on the EC8C declared by the LGA Returning Officer.

"It would interest you to note that the collation of the Egor LGA was not done at the designated LGA centre but was moved to the INEC State HQ and the PDP agent was not allowed access to be part of the exercise."

The Edo PDP chairman also cited examples of alleged deductions of votes from his party's scores "recorded for Etsako West LAG on the IREV shows that the APC obtained 29,858 votes while 32,107 votes was recorded in the EC8C declared by the LGA Returning Officer."

He explained, "While for the PDP, a collation of the votes from the results uploaded on the IREV is 16,712 but 17,483 was returned on the EC8C declared by the LGA Returning Officer.

"The above highlighted irregularities which are very apparent are extremely scandalous and a brazen attempt to steal the mandate of the PDP and also a terrible embarrassment to the commission.

"We therefore demand the immediate re-collation and recomputation of the actual results for the various polling units in the above highlighted Local Government Areas in compliance with the INEC guidelines and regulations which mandates that votes from various units and wards be properly collated."

norship Election, express concern over the transparency of the ongoing results collation by the Independent National Electoral Commission (INEC).

"Reports of disruptions at ward and local government collation centres, including intimidation of INEC officials and attempts to collate results contrary to the provisions of the Electoral Act and INEC guidelines, raise significant concerns about the credibility of the results collation process.

"We acknowledge INEC's recent statement recognising reports of result mutilation and its commitment to investigate and address any proven violations."

It added, "In light of this, we urge INEC to invoke its powers under Section 65 of the Electoral Act 2022 to review any declarations and returns where results were not declared voluntarily or violated provisions of the Electoral Act and INEC regulations, and guidelines.

"We further call on security agencies to refrain from interference in the collation process and to ensure that accredited party agents, the media, and election observers are granted full access to collation centres. We wish to emphasise that the role of security agencies in the election is to safeguard the process and not to create a situation that will undermine the transparency of the process and thus impact negatively on the credibility of the outcome of the election."

Meanwhile, President Bola Tinubu has congratulated Senator Monday Okpebholo, the All Progressives Congress candidate in Saturday's Edo State governorship election, on his victory at the polls.

The President's Special Adviser on Information and Strategy, Bayo Onanuga, said Tinubu commended APC national leaders, Edo State leaders, and party governors for working hard to achieve victory.

He said the victory testified to the people's support for the ruling party, its progressive ideals, its economic reengineering programme and its commitment to improving the lives of Nigerians.

Tinubu urged the governor-elect not to gloat over his victory but to see it as a challenging call to service.

He encouraged him to demonstrate magnanimity by reaching out to his political rivals and uniting the people of Edo State to ensure its development.

lection debates, which should naturally be an integral part of the electoral process, have continued to receive negative reviews in Nigeria and could be thrown into the gutter when the fight for political supremacy commences in the build-up to the 2027 presidential elections.

An indication of the diminishing value of election debates in Nigeria came to the fore on September 15 in Edo State, Nigeria, after governorship candidates of the All Progressives Congress and the People's Democratic Party failed to show up for a debate.

The South South state went to the polls on Saturday, September 21, 2024, to elect a new governor and eventually capped off a difficult off-cycle election that saw so much bad blood between three of the main candidates and their backers.

Monday Okpebholo (APC), Asuerinme Ighodalo (PDP) and Olumide Akpata of the Labour Party, were supposed to use a debate stage to sway voters into voting for them before the hotly contested election took place, but the APC and the PDP men decided to rain on people's parade.

Thereafter, disappointed organisers of the debate, the Nigerian Union of Journalists and the Broadcasting Organisation of Nigeria, including would-be viewers on the all-important day the debate should have held, were left reeling in bemusement.

It, therefore, led the Executive Secretary of the Nigeria Elections Debate Group, Eddie Emessiri, to condemn the last-minute withdrawal and then appeal to Edo voters to demand accountability from those seeking political offices in the state.

Besides Emessiri's criticism, a famous political activist from Edo state, Aisha Yesufu, who was also frustrated by the action of the APC and PDP candidates, had a few choice words for them.

Yesufu told Edo people at the venue of the abandoned debate, "Let me tell you something, the people that you have (in government), the APC and the PDP, are ready to give us bad governance.

"They are ready to suppress us. Their parents suppressed our parents. They have suppressed us and we must not allow them to suppress us and oppress our children.

"This Nigeria belongs to all of us and we must get a country and a state where the child of nobody can become somebody without knowing anybody."



Diminishing value of election debates in Nigeria

From Olusegun Obasanjo, Umaru Yar'Adua, Goodluck Jonathan, Muhammadu Buhari and even incumbent President, Bola Tinubu, the story is the same.

In 1999, Obasanjo blamed his failure to turn up for a presidential debate on "lack of proper invitation."

At the time, the former military Head of State, who left his opponent, Olu Falae, to debate alone, denied having "shied away" from the debate.


By 2007, Obasanjo's successor, Umaru Yar'Adua, also missed the debates. Only the defunct All Nigeria Peoples Party's candidate, Buhari, and Pat Utomi of the African Democratic Congress, slugged it out.

In 2011, Jonathan and Buhari could not spar on the debate stage because Buhari had attended the first of two debates organized for presidential candidates and Jonathan did not.

When it was time for the second debate, Jonathan was present at the venue but Buhari and other opposition candidates were absent.

Buhari later said he did not attend because Jonathan failed to attend the first debate.

In 2015, Buhari declined the offer to attend any debate. His party, the APC, said some Nigerian media organisations were compromised. The party also questioned the "independence" of some organisers of the debate. Although Buhari won the election in 2015, he did not attend any debate in 2019. His rival, PDP's Atiku Abubakar, said he would not attend the debates Buhari failed to honour.



host such debates, not to give any TV station preference. They also said the hectic campaign schedule was another reason why Tinubu would dodge the debates.

Concerning the Edo State governorship election debate boycott, a political affairs analyst, Kizito Opara, said that the disposition of political leaders to past debates influenced the decision of the APC and PDP candidates. However, he said that in President Tinubu's case, debates were actually avoided during the presidential race for "strategic reasons." Opara also said that other candidates would gain some advantages over the former Lagos State Governor because he was not a "fast speaker." of the President and other notable politicians who are accused of not laying a solid foundation for debates attendance that candidates in Edo State decided to act like scared kittens

"However, if you ask me, I will earnestly tell you that President Tinubu avoided the debates during the last general elections for strategic reasons.

"Every Tom, Dick and Harry knows that the President is not a fast speaker. Against other faster speakers, he would have capitulated and found it really difficult to keep up with them. In fact, time will always be against him when he is putting his thoughts together into words on the debate stage.

"His handlers, during the campaign, knew this and so they vetoed every outing that involved a debate.

"Very soon, the election will be upon us, and we will still see the same proceedings in 2023 play out in 2027. Anyone thinking of seeing the President on a debate stage then should thrash the idea. It will not happen.

"And if it happens, it would be very remarkable.

"I know the likes of Obi and Atiku will be very eager to debate the President. Unfortunately, they should look for other means of beating Tinubu. It certainly won't be through a debate. A seasoned socio-political commentator, Chidi Egbule, told *The Point* that debates have never helped candidates during presidential elections in Nigeria to clinch victory. dential candidate has ever won an election based on what he articulated to Nigerians during a debate. It has never happened. And do you know why? It is because people only vote for political parties in this part of the world.

"On the contrary, in many foreign countries, candidates have used debates to gain much-needed lead in opinion polls and used that momentum to win elections. In Europe and America, how you perform in a debate can change the course of your candidacy for the best.

"Look at, for instance, what Donald Trump of the Republican Party and Kamala Harris of the Democratic Party did with their own debate.

"Over 61 million viewers watched it because it could either make or mar any of the two candidates.

"Here in Nigeria, nobody cares about what you plan to do for the country. Nobody also cares about what you say. We were here when they asked a particular candidate in Edo State to come to a debate and pass his message on the debate stage using Pidgin English.

"You see, as long as you can distribute 10kg bags of rice to our people, you are the best debater," he said.

Some political commentators have said that the likes of Okpebholo and Ighodalo should not be entirely blamed for their flagrant decision to skip the debate.

According to these commentators, political leaders in the country, especially the ones that graced the polity since the start of the Fourth Republic in 1999, are notorious for not attending debates even if their lives depended on it.

Astoundingly, practically every Nigerian leader that contested and won a presidential election has, one way or the other, avoided a debate or two. Before the last presidential election in 2023, opposition presidential candidates, Atiku (PDP) and Peter Obi (LP) called for a debate with the candidate of the APC, Tinubu, but that request was not granted.

Tinubu's team resolved, because of the many radio and television networks in Nigeria that indicated to

"I concur with those who have been saying that it is because of the action In his assessment, Nigerians only vote for political parties and not what a candidate would articulate during a debate.

"Who has debates helped in Nigeria? I think debates are a waste of time in Nigeria. I stand to be corrected, but no presidential candidate who ever took part in a debate won an election on the strength of that debate.

"Let me repeat myself, no presi-s

to determine candidates' fitness was through a debate.

"The debates, too, would have helped us to know which candidates are healthy and fit. The debate between Trump and Harris also told us a lot about their staying power.

"Both American candidates stood up for more than 90 minutes. Trump who is 78 years old was also noted to be agile, sharp and fit. Through that debate, we saw that he was healthy and rearing to go.

"Can we say all that for our leaders? We surely have a long way to go," he submitted. ●



I'm a PDP man, if tomorrow Plateau people tell me to move, I'll move – Governor Mutfwang

In this interview, the Governor of Plateau State, Caleb Manasseh Mutfwang, speaks on numerous topical issues including his relationship with President Bola Tinubu, the forthcoming local government election in the state, how to improve infrastructure in the state and payment of backlog of pensions, among others. Excerpts

What has been the story since you came on board as Governor of Plateau State?

You know that governance continues daily. It keeps improving; it's like a football club, every season, you see clubs buying new players because they need to improve the competitiveness of the squad.

I am happy with my squad; but I'm always looking for ways of improvement. As soon as we find ways in which we can improve, we will bring in the best hands that can be recruited.

Recently, you suspended two of your commissioners. When that was done through your Director of Press, you didn't tell the world why you did it. May we know why it was done?

Well, let me say that we suspended them in order to reinforce discipline within the cabinet. Where we see some bit of lackluster disposition, we try to rein them in and make sure people sit up to their responsibilities. We can't for political reasons, allow anything and everything to go. But I am sure those we suspended have learnt their lessons; and we will keep reviewing those suspensions.

There was an appointment you made recently which generated a lot of fuzz. I'm sure you saw the reactions even from the Jama'atu Nasril Islam about a Senior Special Assistant on Indigenous Muslims. There seems to be too much hues and cries. I don't know if you want to explain anything in that light?

I really don't like generating storms out of tea cups. It's not necessary. I didn't create the idea of "Indigenous Muslims". I met it on the ground as governor. It has been in existence, and even registered with the Corporate Affairs Commission as indigenous Muslims.

I don't know what motivated them; but they are definitely a defined group within

we don't just throw something at the large group and some people within that group feel disenfranchised, feel disentitled, and feel not included. That is why you can see for the first time in the history of Plateau we recognised different groupings and gave them a channel of relating with the government. We are running on this mantra of inclusion, equity, and fairness to all. Now, if you are getting your own, don't deny somebody the opportunity to get his own. That's all we are saying.

It appears you have a smooth relationship with Mr. President; to the extent it is feared that you may want to possibly jump ship someday. Are you thinking in that direction?

First of all, let me appreciate Mr. President for accepting me and opening his arms of fellowship to me. After all, he is the father of the nation. For instance, as the Governor of Plateau State, I cannot discriminate against any Plateau citizen. And so, for me to have that access to Mr. President, I believe it's for the good of Plateau people.

Let me say this, I'm a PDP man to the core. My politics has always been dictated

LET ME SAY THIS, I'M A PDP MAN TO THE CORE. MY POLITICS HAS ALWAYS BEEN DICTATED BY GOD AND THE PEOPLE. AND I KNOW THAT PLATEAU PEOPLE OWN PDP. THEY SEE IT AS THEIR OWN. IF TOMORROW PLATEAU PEOPLE TELL ME TO MOVE, I'LL MOVE by God and the people. And I know that Plateau people own PDP. They see it as their own. If tomorrow Plateau people tell me to move, I'll move. But if they tell me we want you to stay where you are, that's where I will stay. So, I will always move with the people. Let me assure the people about this; I will always move with the people. I relate well with Mr. President; but I don't forget where I come from.

Just a few days ago, the APC stakeholders on the Plateau met. Since you have this good relationship with the President, do you have any information to give us in the light that Plateau has been without a minister for a very long time, even though you don't belong to the APC?

The federal cabinet is a right, as enshrined in our constitution. And I've had to engage Mr. President on this. He has asked me to be patient. He is trying to rejig his government and certainly has not forgotten about Plateau.

He is considering a lot of options. Of course, we will keep engaging him on this matter. Presently, the National Assembly is in recess – the Senate, particularly. I'm sure that when they resume, we are likely to hear something positive in this regard.

May we know what your administration is doing to address the quality of taxes imposed in the state?

On the issue of tax on land tenancy agreements, it's not something that we created. I know that the Joint Tax Board – which is a national body of all the states – usually has all the tax heads in charge come together. Normally, if you have a tenancy agreement, it's supposed to be registered with the government; and you are supposed to pay something on it.

But I'm not sure that many landlords in operation today have tenancy agreements; and I can assure you, they are not paying anything to the government. So, if they are charging you extra, it is not because they want to pay the government. But we will soon be dealing with all the issues around tenancy rates in Plateau State. We are not going to leave it for landlords to take advantage of people. We are going to come into that space quite soon.

Recently, the government moved against the location of certain parks. What is the motive behind that action?

On the issue of illegal parks, let me say it loud and clear

criminality. We are not going to allow it to continue. We want to encourage those who were shut out of NTA Park to make use of the one in Jos South.

It's for your good and safety, because we want to make sure that both passengers and motorists are not put in danger. We want to appeal to people who are operating those motor parks to know that their days are coming to an end. We'll definitely get them out of those spaces. But let me also assure you that we are going to create decent motor houses all over the city for people to have access to.

Again, on the issue of parks, we are also making arrangements to construct modern parks into the city gates from the Riyom, Bukuru, Mangu-Foron-Barkin Ladi, Zaria and Bauchi road axis.

We are looking at how to be able to bring modern facilities in that regard. Again, we like this to be private sector driven. That's why it's taking us a little bit of time because we want to cross the T's and dot the I's.

What is the deal for pensioners in the local and state governments? Do they have reason to smile under your government?

Pensioners at the local government are something that has challenged this administration dearly. We have a backlog of over N15 billion at the local government; another, close to N20 billion at the state level. We are looking for ways on how to clear those pension liabilities as much as we can. It's not going to be easy; but we've started discussions with our financial advisors. And, so, we are looking at various options to deal with the pension issues with the local government autonomy that is upcoming. It's going to be a challenge; but we'll look at it, and see how to navigate it.

our space. And so I didn't create them. I only said, "Okay, look, you guys exist, let's see how you can relate better with government". That's all we did. Therefore, I don't see why anybody should deny them the right of existence. Some of them are Berom, some of them are Mwaghavul, some of them are Ngas, and others are Tarok.

They want their own identity. And there is freedom of association guaranteed under the constitution. So there is no need to deny anybody that right. So, we simply recognised what is in existence. We didn't create it. What we have done in trying to recognize the various groups is to give everybody a sense of inclusion so that that we are going to regulate motor parks. We have started; we shut down the one in NTA because unregulated motor parks are dens for

Mutfwang

What are your plans for the provision of water in the Jos/Bukuru metropolis?

We have already started to take a look at the issue of water supply on the Plateau, especially in the metropolis. It is a huge challenge on the ground. But we are working on it. What we have done is to reorganize the administrative machinery in the water sector. You may have heard

that I appointed a Special Adviser on Water Management recently. It's because of the kind of plans we have. We cannot sustain urban water supply with boreholes. We have to have a comprehensive water scheme that can supply the city

effortlessly. It is going to be challenging. With all the dams we have, we should be able to have sufficient and quality water supply on the Plateau. But the pipes to carry the water from Lamingo and Shen dams, and all the other dams, we have already put together; we are equally working on them. It is not a one-day solution. But we hope that will really improve urban water supply by God's grace.

There are some grant-aided missions and other private schools giving quality education, but they are limited. May we know if you are thinking of their sustainability?

I am a product of a grant-aided school. I went to Gindiri, as you know, which is a quasi-public school because it's not an individual that owns it; and it's not for profit. So, it's something desirable. But we are working, trying, to first of all improve our financial capacity. Once we do that, we are going to look at how to be able to aid those schools. I believe in that policy; but we will look at it within the limits of our resources.

It may not be immediate; but we will certainly attend to it at some point in time. On the issue of scholarships, certainly we have improved on the scholarship scheme we met on ground because when we came in, I think every student was being given N4, 000, which was owed as at last year. I remember that I approved close to N300 million to be shared to students. We have also reduced the school fees for Plateau students in the tertiary institutions owned by Plateau.

We are always looking at how to improve that for the Law School students. Maybe because I'm a lawyer, you know, we're able to pay some of their fees. And we are looking at how to encourage professional development of our students.

There are health concerns at the Jos Abattoir. What can you do to bring it to standard using best practices?

I've listened to the pleas about the abattoir. One of the projects that are dear to me is that abattoir. We are going to rebuild the abattoir to a modern facility. We are making arrangements to do that. You need to know this, presently big hotels like Transcorp import meat from South Africa. Because they claim that our meat production is not up to international standards. There are countries that are waiting to even import beef from Africa. And they have identified Plateau State as one of those states they can import beef from. Therefore, we are making plans to set up a modern abattoir which would mean that all the butchers will have to be trained and retrained. Some of them may have to run other ancillary facilities linked to the abattoir. They need to also know that the butchery business is no longer going to be for those who didn't go to school. So, they need to start improving on themselves now.

The local government elections are just a few days away. You have repeatedly said you created a space where it would be a level playing ground for everybody. The people don't believe that what you're saying is going to happen. Your party had a bit of a stormy ride in the primaries. The other party seemed to be very quiet. They did their primaries and everything went on smoothly.

Did they do primaries? They didn't do primaries. I can tell you that for free. Let them challenge me hereafter. Let them tell us where they did primaries. They didn't do primaries for governorship. Names were just written; they didn't do for local government elections either. But let me say this, we are going to prove to Nigerians that Plateau is a model in terms of conducting local government elections. We are bringing international observers to observe our local government elections. The reason APC is participating is because we have provided a level playing field. You remember the shameful local government elections conducted in 2021 where they excluded the PDP on a very frivolous and scandalous basis, which was decided in the Government House, not even by PLASIEC.

We witnessed situations where before results could be counted, people were already announced and sworn in. That is not going to repeat itself on the Plateau. By the grace of God, we're going to conduct credible local government elections. I was a beneficiary of such credible elections in 2014, when I became a local government chairman. I cannot go below that standard.

Plateau people should be reassured that we'll do the best we can, to ensure that we have credible local government



For us in the PDP, we had hiccups here and there. Truly the party belongs to the people, if we had situations where communities' members emerge as consensus candidates rather than by the party itself; because communities took ownership of the party. And we are glad about that.

But let's not exaggerate it. We had a few skirmishes in two or three local governments out of 17. And what I can tell you is that we brought everything under control. Of course, when you have a contest, some people will be aggrieved – it's normal; but we are addressing it. And I am sure before the elections everything will be well, and we are going to go into the elections, as far as the PDP is concerned, as one happy family

It appears that some of the people you started with in your journey through your campaign appear not to be getting your attention anymore – they have been left in the cold. What is your position on this issue?

You know, the government does not begin and end in one day. People have expectations that once you come into government, everybody is going to get an appointment. Everybody is going to get one thing done or the other. It doesn't happen in one day. People have to learn to be patient. There is no way I can cut myself into pieces and give everybody. When I was chairman of Mangu, I had this very naive idea that I could be seeing everybody. So I created two days in the week. The first two weeks, I almost died because there was no way I could see everybody. Now,

I'm going to get journalists to keep company with me for a week and see my schedules. I believe that among many governors, I'm doing my best to be able to allow access to me as a person. I answer phone calls when the time allows; reply text and WhatsApp messages. I engage people, when I have the freedom.

But when somebody calls you, maybe you are even having a state executive council meeting; he wants you to answer his call. So let me appeal to those who feel they haven't been carried along to continue to be patient.

We'll continue to look out for that. And people who know me know that I have no enemies or friends when it comes to governance.

If you have any value to add to Plateau people, we'll bring you on board. Some of those who competed with me during elections are in different offices today. Appointments were facilitated, you know, so we'll continue to do that. I appeal to people who have such feelings, let them continue to be patient.

What measures are you putting in place to help get sponsors for Sport teams in Plateau State, especially through companies existing on the Plateau? What are the companies giving back to the state as it will lessen the general burden on your government in funding these local teams?

We are trying to reorganize sports from the grassroots and look at various aspects of the administration of sports as it is presently. Government is bearing the burden for virtually all the teams, whether in football, basketball, badminton, every aspect of sports, because when we got on board, the Sports Council was almost dead.

We've been able to bring in one of our veteran sports administrators, Professor Ezra Gunnen. We brought him from Abuja to become Director of Sports. He was a record holder in 1500 meters here on the Plateau. We are thinking of how to be able to rebuild from the base.

Of course, part of the critical thing that was coming was the contributions of the private sector. But before you ask the private sector to give, you must first of all also give them.

So we are looking at what the enabling environment is. What is the enabling environment for the private sector to thrive? They don't do Father Christmas; they do what is called corporate social responsibility – which is done after they have made profit.

yet taking women as equals and so they have to create a special position for them in the parties.

The president has been in office for 16 months, what is your assessment of his administration?

I am sorry to say that I think it has been a disaster. It has been a complete disaster because Muhammadu Buhari's government was bad enough and one would have expected that Tinubu would have tried to turn things around, but he has not done that. He has been playing in the gallery. He has, in fact, been spending money on himself and his cronies, instead of actually doing something to better the life of the ordinary man.

What do you have to say about security?

Well, security is worse than ever because before, terrorists were in the North ravaging the place. Now they have moved down South and now we are having kidnapping in virtually every corner of Nigeria. I believe he has to make sure that the security apparatus is overhauled.

Some people are saying that the terror-

ists are in Sambisa forest. Why can't the army go into Sambisa forest and get rid of them. They know where the terrorists are. These terrorists are phoning people. Somebody is using the phone, you can locate him wherever he is. Whenever I get to London, I get a welcome message on my phone saying, 'Welcome to London.' So once you have a phone, you can be traced anywhere. In fact, I was watching a television this morning and one of the things being said was that all these people, those who were fighting in Lebanon, the terrorists in Lebanon, they don't use phones, that's why they were using pagers because they knew that they could easily be traced by the use of their phones. So, how is it that terrorists can phone people and ask for ransom and the police and the military cannot trace them and deal with them?

If you had the opportunity to meet the president, how would you advise him to address the situation in the country?

I don't think the president would want my advice. I don't think he is the kind of person that takes advice. After all, I was his deputy. I don't believe he is the kind of person that takes advice. He seems to have the mindset that he knows it all

But for the benefit of the doubt, what kind of advice would you give him?

Well, I would advise him to look around the country; we have qualified and capable people in this country who can give him the right advice and show him the way as to how to run the country. My advice is that he should look into the security situation in the country very seriously because as long as there is no security, we would not have development because people would not invest in an unsecured country.

CBN's tightening policy fails to stem inflation tide 26m Nigerians to further go down poverty threshold - Experts Analysts predict rise in headline inflation to 32.40% in September **Highlight challenges facing CBN**

figeria's annual inflation has remained elevated despite varying reforms by the Central Bank of Nigeria targeted at easing the 28-year-high consumer price index.

As a result, the country's poverty risk heightens because the CBN's tightening policy has failed to stem inflation tide.

According to analysts interviewed by The Point, inflation remains a herculean task for the apex bank despite the numerous achievements of the Cardoso-led bank in tackling economic challenges that have bedeviled Nigeria in the last one year.

Inflation which measures the stan-

Nigeria are anticipating another potential interest rate hike.

Under Cardoso, the CBN has already increased the Monetary Policy Rate four times this year, raising it to 26.75 per cent.

These hikes, totaling 800 basis points, have been driven by persistent inflation, particularly in core and food sectors.

With inflation reaching 24.08 per cent in August 2024, many financial analysts believe another rate hike could be imminent.

An economic analyst, Okechukwu Eze, pointed out that while these increases help combat inflation, they also burden manufacturers who rely on loans.

He noted that while the increases



with interest rates exceeding 25 per cent. Many have either slowed down growth or looked for alternative funding sources, including equity financing."

He noted that manufacturers are particularly impacted, as banks offer varying lending rates.

"Prime rates for the most creditworthy borrowers range from 7.00 per cent to 22.00 per cent, while maximum rates can reach up to 48.00 per cent, making borrowing costly for businesses," Okezie added.

Another expert at the Lagos Business School, Bamidele Akanbi highlighted the challenge facing the CBN.

He said, "While inflation is the primary concern, higher rates will further strain businesses already grappling with rising costs and limited credit access. "Inflation remains stubbornly high, and without more action from the Central Bank, the risk of inflation spiraling out of control is significant. But the trade-off is that higher interest rates will further burden businesses already struggling with rising costs and limited access to affordable credit," he said.

growth in price level may cool off on the back of bumper harvest and the president's tariff-free food importation

"The economy will remain largely overheated for the foreseeable future," Simon said.

He noted that raising interest rates might not have been effective in tackling high inflation thus far, cautioning that instead of aggressively hiking rates, the impact of previous increases should be observed.

"As monetary policy has a long and variable lag, the CBN should not be too hawkish and for too long," the Abuja-based economist said.

The managing director, Time-Line Consults, Shuaib Idris, said a further hike in the MPR will not have the desired effect in reducing inflation, noting that the government should find ways to mop up excess liquidity in the economy. "If the CBN doesn't reduce the rates, they should leave it as it is. The quantum leap in the MPR is too high, and it is strangulating the business environment. "The actual value of a dollar in naira terms should be about N900. But because of this excess liquidity, we are now working with about N1560/\$. What we need is a liquidity

dard of living of a people, depending on the number, has remained one of the biggest undoing of the Nigerian people as the cost of living has skyrocketed in the past few years.

Although inflation has dropped in the last two months, financial analysts said it is not yet 'Uhuru' as the figures might spike in September.

According to a report sighted by The Point, over 26 million Nigerians will further go down the poverty threshold due to food insecurity.

As the CBN Monetary Policy Committee prepares for its September 23-24 meeting, businesses across are necessary to control inflation, they pose challenges for manufacturers relying on loans to fund operations.

"The elevated rates increase the cost of production, which may eventually be passed on to consumers," Eze said.

Another financial analyst at Vetiva Capital, Nneka Okezie, said that "The financial pressure on companies is immense."

He added that "Businesses that rely on credit for working capital or expansion projects are finding it harder to justify taking out loans

squeeze, to remove the excess liquidity in the system," Idris added.

The analysts have therefore called for more fiscal measures to complement the reforms of the monetary authorities to stem the tide of accelerating inflation.

"Even though the CBN's main focus is tackling inflation, it cannot do that alone as the main driver of inflation is food inflation. And the production of food is not within the CBN's remit," Simon said.

He noted that to come out of the woods, there is a need to tackle insecurity for farmers to go back to their farms, which will in turn increase agricultural yield through affordable and improved farm inputs.

Nigeria recorded a drop in inflation for two consecutive months of July and August 2024. Data from the National Bureau of Statistics published in September showed that the Consumer Price Index stood at 32.15 percent in August. It is the lowest level since March.

Cardoso had said in January this year that he will bring inflation down to 21 percent in 2024, and considering the two months drop recently achieved, the belief in some quarters is that inflation might continue to taper.

However, some other schools of thought have warned that inflation might spike as a result of the decision of the government to further worsen the accessibility of fuel by further increasing pump price from N617 per litre to N897 per litre as announced by the NNPCL in September.

As a result of the shocking increase, fuel prices have risen above N1, 000 per litre in some states in the country, further impoverishing all Nigerians.

The Chief Executive Officer, Financial Derivatives Company Limited, Bismarck Rewane, in a post-inflation review report, warned that a decline in inflation for two months does not suggest that it will continue to go down as expected in some quarters.

He noted that inflation risks remain elevated. Rewane further stated that it was not the tightening policy of the Monetary Policy Committee of the CBN that aided the current drops witnessed in CPI but the harvest season and base effect

"Noteworthy, two readings are not a trend, especially as inflation risks remain elevated. A breakdown of the data showed that the continued moderation in inflation is largely due to the harvest season and base year effects. Year-on-year food inflation moderated to 37.52% from 39.53% in July," he said.

Nigeria's poverty risk heightens items less farm produce and energy) increased to 27.58 percent and 2.27

percent, respectively, from 27.47 percent and 2.16 percent. "The increase suggests that inflation

is more structural than transient and could be attributed to currency pressures amid forex scarcity.

"The naira depreciated by 4.2 percent in August at the official market compared to 3.1 percent in July. Additionally, the upward movement in the core inflation rate indicates that underlying price pressures are building. If this trend continues, it could counteract any short-term improvements in the headline inflation trend.

"Recent occurrences like the 50% rise in PMS price with its knock-on effect on logistics and food prices, the 62.66% growth (y-o-y) in money supply (M3), and exchange rate volatility are factors that could potentially reverse the disinflationary direc-

search Ltd have predicted a rise in headline inflation to 32.40 percent in September.

"Regarding core inflation, we foresee a further increase driven by higher energy costs, increased naira volatility, and rising transportation expenses. As a result, we forecast core inflation to climb by 12bps to 2.39% m/m, pushing the y/y rate higher to 26.76% (August: 26.36% y/y). Accordingly, we project the headline inflation to increase by 2.29% m/m in September, cascading to a y/y inflation rate of 32.40% (August: 32.15%

y/y)," they stated.


CBN'S TIGHTENING POLICY

When Cardoso assumed office as governor of the CBN on September 15, 2023, inflation was 26 percent.

Despite the tightening measure of the CBN which led to the base lending rate rising to 26.75 percent in July, inflation grew steadily to over 33 percent.

Precisely, in its fourth consecutive hike since February, the CBN recently increased the MPR by 50 basis points to 26.75 percent in July, from 26.25 percent.

"Inflationary pressures are ex-





pected to decline in 2024 due to the CBN's inflation-targeting policy, which aims to rein in inflation to 21.4%," Cardoso said in a speech, a copy of which the CBN shared by email.

He added that improved agricultural output and the easing of global supply chain pressures would boost consumer confidence and purchasing power.

The CBN is expected to pursue a more conventional monetary policy approach under Cardoso after years of unorthodox policies pursued by his predecessor, Godwin Emefiele.

In November 2023, Cardoso announced the adoption of an inflationtargeting framework.

President Bola Tinubu made a series of reforms after becoming the president last year, including scrapping a petrol subsidy and easing currency trading restrictions.

However the country still has a shortage of forex and suffers as a result of a wide gap between the official and parallel market exchange rates.

Nigeria has been battling a serious economic crisis due to the removal of petrol subsidies and a raft of measures adopted by the Federal Government, which the Cardosoled CBN has deployed all monetary policy tools to fight.

Experts argued that the tightening policy of the CBN has not achieved its desired impact in reducing currency in circulation aimed at curbing inflation.

Data from the CBN showed that rather than the currency in circulation shrinking, it's expanding more. Currency in circulation exceeded N4 trillion in June 2024, the first time in history.

The latest data from the CBN shows that the currency in circulation reached a year-high of N4.05 trillion in June 2024, up by 56 percent from N2. 6 trillion in the same month of the previous year.

HUNGER THREAT

Nigeria is expected to see about 26.5 million people grappling with high levels of food insecurity, as disclosed by the Federal Government and its partners.

Moreover, approximately 9 million children are at the risk of suffering from acute malnutrition or wasting. Of these, an alarming 2.6 million children could face Severe Acute Malnutrition and require critical nutrition treatment.

Since drop in food inflation is the main reason why the CPI moderated for two months, FDC hopes the MPC will mellow down on its tightening stance to allow for output growth in the economy.

Nigeria's GDP climbed to N60.93trn in Q2, 2024 - FG

he Federal Government has disclosed that Nigeria's economy recorded substantial growth in the second quarter of 2024 as the country's nominal Gross Domestic Product hit N60.93 trillion during the period.

The government has attributed the development to its dedication to the implementation of economic policies aimed at identifying inefficiencies and ensuring that resources are effectively utilized.

The Permanent Secretary of the Federal Ministry of Finance, Lydia Jafiya, disclosed this during a sensitization programme about the upcoming implementation of quarterly citizens and stakeholders engagement, held at the ministry headquarters in Abuja last week

Jafiya highlighted that the programme represents a crucial step towards enhancing the transparency and accountability of financial policies and strategies.

She said the ministry has spearheaded several reforms aimed at improving revenue generation, reducing leakages, and ensuring fiscal discipline which has in turn improved the nation's GDP.

She noted that Nigeria's nominal GDP reached N60.93 trillion, marking a 16.94 percent increase from the N52.103 trillion recorded in the same quarter last year.

Expatiating on the development, Director of Information and Public Relations, Mohammed Manga, in a statement on Friday said the GDP growth in Q2 was primarily fueled by the services sector, which experienced a 3.79 percent growth and accounted for 58.76 percent of the total GDP.

The agriculture sector grew by 1.41 per cent from 1.50 per cent recorded in the second quarter of 2023, while the industry sector grew by 3.53 per cent, an improvement from -1.94 per cent recorded in the second quarter of 2023.

The statement read, "It is per-tinent to note that despite the challenging economic outlook, economic growth strengthened in the second quarter of 2024, with GDP growth by 3.19 per cent (year-on-year) in real terms.

"This growth rate is higher than the 2.51 per cent recorded in the second quarter of 2023 and higher than the first quarter of 2024 growth of 2.98 per cent. The performance of the GDP in the second quarter of 2024 was driven mainly by the services sector, which recorded a growth of 3.79 per cent and contributed 58.76 per cent to the aggregate GDP. The agriculture sector grew by 1.41 per cent, from the growth

of 1.50 per cent recorded in the second quarter of 2023.

"The growth of the industry sector was 3.53 per cent, an improvement from -1.94 per cent recorded in the second quarter of 2023. In terms of share of the GDP, the industry and services sectors contributed more to the aggregate GDP in the second quarter of 2024 compared to the corresponding quarter of 2023. In the second quarter of 2024, aggregate GDP at the basic price stood at N60, 930,000.58 million in nominal terms."

She further informed that "This performance is higher when compared to the second quarter of 2023, which recorded aggregate GDP of N52.1tn indicating a year-on-year nominal growth of 16.94 per cent."

ICPC recovers N4bn stolen funds in 24hrs

he Chairman of the Independent Corrupt Practices and Other Related Offences Commission, Musa Aliyu, SAN, has disclosed that his team recovered a whooping N4 billion in stolen funds within 24 hours.

He stated this while addressing participants at the One-Day National Anti-Corruption Coalition, Members Hybrid Interactive

Inancial experts have attributed the continuous climb of short-term interest rates in the Nigerian money market to liquidity pressure within the financial system, noting that, although there have been outflows from auctions conducted by the Central Bank of Nigeria, inflows from maturing instruments have remained limited.

A report by Cowry Assets Limited noted that "Significant amounts have been withdrawn for FX auctions and the sale of Nigerian Treasury bills to local deposit money banks, which typically invest in short-term securities. These and other related outflows have kept the liquidity balance in the negative for an extended period. "As a result, several authorized dealer deposit money banks faced liquidity shortfalls, prompting market participants to seek funding through the Central Bank of Nigeria's Standing Lending FacilForum held at ICPC headquarters in Abuja at the weekend.

"We recovered close to N4 billion from public funds, within twenty-four hours (from 18th to 19th September 2024,) which has left the government coffers in private custody," he said.

According to the ICPC boss. "It's alarming to see how much money is being misappropriated, and some individuals have bil-

lions of naira in their possession for personal gain. It's a shocking reality that people are hoarding public funds instead of using them for the benefit of the nation."

The ICPC boss also reiterated the need to invest more in technology which will help minimise the challenges of corruption, particularly in public procurement.

"By implementing tech-driven processes, we can reduce practices

like contract inflation.

"And as a commission, we are utilising technology and management systems to restore confidence in the fight against corruption. We are committed to ensuring transparency in this endeavour.


"Also, using technologies like block chain can help eliminate manipulation, ensuring the integrity of public procurement," he added.

Speaking on the development, an economist and investment expert, Vincent Nwani, said, "The CBN is expected to raise N50 billion from the cyber security levy before the end of 2024.'

By applying the 0.005 percent levy to this amount, the estimated revenue comes to about N49.35 billion.

He added that in 2022, electronic payments totaled N387trn, generating N19.35bn from the levy, while in 2023, with transactions soaring to N600trn, the revenue from the levy reached N30bn.

"For instance, we saw a remarkable 55 per cent surge in the total electronic payments, from N387trn in 2022 to N600tn in 2023 and the 2024 figure is projected at N999.9trn. At 0.005 per cent cyber security fees, the Nigerian government will earn N19.5bn for 2022, N30bn for 2023; 2024 will be equivalent to N50bn [projected figure] from its citizens," he expounded

Enacted under the Cybercrime (Prohibition, Prevention, etc.) (Amendment) Act 2024, the 0.005 per cent levy, applies to all electronic transactions and is intended to fund the National Cybersecurity Fund managed by the Office of the National Security Adviser. Despite initial resistance from President Bola Tinubu and the House of Representatives, who had called for a suspension and review of the policy, the CBN has restated its resolve to enforce the levy.







Financial, oil & gas stocks drive bullish performance on NGX as investors grab N455bn gain

Inancial stocks comprising Banking and Insurance as well as stocks in the Oil & Gas sectors emerged as key drivers of activities on the Nigerian Exchange Limited in the week ended September 20, 2024, with investors taking away about N455 billion as gains from their dealings.

Sectoral analysis revealed resilience, particularly in the Banking, Insurance, and Oil & Gas sectors.

The Banking Index led sectoral gains, rising by 1.26 percent week-on-week, driven by strong investor demand. The Insurance sector followed with a 0.86 percent increase, while the Oil & Gas sector posted a marginal 0.02 percent gain.

The Nigerian equities market sustained its upward momentum in the review week, buoyed by consistent buy sentiment as investors reacted favourably to the latest inflation data, which moderated for the second consecutive month to 32.15 percent.

Additionally, quarter-end window dressing activities contributed to the bullish outlook, propelling the NGX All-Share Index (ASI) by 0.81 percent week-onweek, from 97,456.62 points to 98,247.99 points, elevating the market's year-to-date return to 31.39 percent.

Market capitalization saw a corresponding increase of 0.81 percent, reaching N56.47 trillion and yielding a weekly investor gain of N454.86 billion.

Despite the positive market performance, breadth was slightly negative, with 41 gainers against 40 losers. Trading activity declined, with average traded volume falling by 28.02 percent to 1.86 billion units, the traded value dropping by 24.92 percent to N38.44 billion, and total deals decreasing by 20.56 percent to 40,211 trades for the week. stocks.

The recent dip in inflation and favourable quarterend activities suggest that investor optimism may persist, creating entry opportunities for those seeking fundamentally sound investments.

According to the National Bureau of Statistics, consumer prices eased for the second consecutive month as the high statistical base from the prior year supported performance. Specifically, headline inflation moderated by 125bps to 32.15 percent y/y in August (July: 33.40% y/y).

Analyzing the breakdown, food prices (-201bps to 37.52% y/y) eased to a 7-month low, while core inflation (+11bps to 27.58% y/y) remained at the highest level since March 2004 (32.60% y/y). On a month-onmonth basis, headline inflation slowed by 6bps to 2.22 percent (July: 2.28% m/m), underpinned by the decline in food prices.

However, experts on the platform of Cowry Asset Limited advise caution as market volatility remains a key factor.

"Investors should maintain a focus on quality stocks with strong growth prospects to navigate potential swings effectively," Cowry said.

Meanwhile, the global equities market rallied in the review week as investors digested a series of policy decisions from the world's major central banks and their impact on the global economy.

Accordingly, US equities (DJIA: +1.5%; S&P 500: +1.6%) were set for another weekly gain driven by positive reactions to the Fed's larger-than-expected 50 bps rate cut and the four-month low print in weekly jobless claims, which reinforced expectations that lower borrowing costs could support labour demand without reigniting inflation. Similarly, European equities (STOXX Europe: +0.4%; FTSE 100: +0.1%) tracked global optimism, heading for a positive close, as investors assessed the Bank of England's decision to keep interest rates steady, alongside the US Federal Reserve's rate decision. Asian markets (Nikkei 225: +3.2%; SSE: +1.2%) posted gains, buoyed by (1) the Bank of Japan's decision to maintain interest rates, (2) expectations of further stimulus from China, and (3) the positive sentiments surrounding the US Fed's monetary easing. Finally, the Emerging Market (MSCI EM: +1.6%) index advanced, driven by gains in China (+1.2%) and India (+1.3%), while the Frontier Market (MSCI FM: -0.1%) index closed lower following the selloffs in Kazakhstan (-0.1%).

Conversely, the Consumer Goods and Industrial Goods sectors experienced setbacks, with declines of 0.77 percent and 0.13 percent, respectively. On the stock level, CAVERTON (+45.3%), FIDELITYBNK (+24.2%), FIDSON (+21.8%), VITAFOAM (+21.5%), and MEYER (+20.9%) emerged as the top gainers for the week, reflecting robust price appreciation. Meanwhile, NNFM (-19.0%), MECURE (-18.2%), TANTALIZER (-14.1%), RTBRISCOE (-12.9%), and NIDF (-9.9%) were among the key laggards, as investors rebalance their portfolios in response to market dynamics.

With the market displaying resilience amid positive macro signals, stock market analysts anticipate continued bullish sentiment this week, driven by portfolio rebalancing and strategic positioning in value-driven THE POINT

Nigerians to Tinubu: We're tired of excuses, lamentations

Will the President – yet again – beg us to endure hardship?" The abovementioned expression is the million-dollar question on the lips of many Nigerians who say they have always been prepared to lend an empathetic ear to the President, Bola Tinubu, whenever he makes one of his many pleas to citizens to endure hardship.

Going forward, however, it seems that the President's usual efforts to strike a chord with Nigerians will hit a brick wall, and this is as a result of the biting economic hardship that has continued to perplex the people.

More exasperatingly, the President's entreaties, which usually come with reassurances that he will turn the country's fortune around, will likely be taken with a pinch of salt and could leave many desperate Nigerians with frayed nerves, making them insist on results – not excuses.

Unfortunately, experts have argued that there is no end in sight yet to the hardship and anguish being experienced in the country. They also say that even though they do not want to be bearers of bad news, it is the downtrodden citizens that will yet languish in lack and penury.

On their part, ordinary Nigerians say that the President will sound like a broken record if he once again attempts to assuage the collective anxiety of Nigerians who are tired of hearing him beg them.

One such Nigerian said he wanted to hear "a new message" from the President.

"I want to hear a new message from Tinubu. I won't like the idea of the President begging us again to endure hardship or to be patient with his government," said Kehinde Afolayan, a bus conductor in Ikeja, Lagos, trying to eke out a living.

"I supported the President when he was the Governor of Lagos State. I am still supporting him today. This is why I listened to his past pleas. As things are now, I am overwhelmed by the hardship in the country.

"We need solutions now that will change our story. Tinubu must hurry up with implementing his economic plans because we can't wait all day" Afolayan added.

Another Nigerian, Hafisat Amusa, who sells foodstuffs in the Egbeda area of Lagos State, said that she does not want to listen to another appeal by the government or "the friends of the gov-

comes after the pain. Nigeria is reborn already with fuel subsidy removal. It is a rebirth of the country for the largest number of smugglers. Please tell the people to be a little patient."

Following the appeal, the former Lagos State Governor, who said becoming President was his lifelong ambition, made several other appeals to Nigerito look beyond the present temporary pains and aim at the larger picture.

"All our good and helpful plans are in the works. More importantly, I know that they will work. Sadly, there was an avoidable lag between subsidy removal and these plans coming fully online."

But, unexpectedly, the video stirred controversy after the Special Adviser to Tinubu on Information and Strategy, Bayo Onanuga, said it was old and a clip from the broadcast the President made last year.

Apart from Tinubu, several prominent individuals have also been spotlighted in the past for pleading with Nigerians to bear with the President.

Some of the persons who made impassioned appeals to Nigerians include two of the President's children, Seyi Tinubu and the Iyaloja General of Lagos State, Folashade Tinubu-Ojo, as well as a former military Head of State, Yakubu Gowon.

Minister of the Federal Capital Territory, Nyesom Wike, a former Governor of Ogun State, Gbenga Daniel, and the Deputy Senate President, Jibrin Barau, who said that the hardship experienced by Nigerians was not peculiar to the country, but a global problem, are among those whose names are also on the list.

Although many Nigerians have exhibited patriotism and decided to build hope up around the pitch made by Tinubu for them to endure hardship, present realities indeed indicate that the people no longer want "the endless appeals and promises" made by the President.

According to Nigerians, the nearly 50 percent increase in petrol price, which came into effect early this month, is in-excusable.

Nigerians are aghast that petrol prices, on an unprecedented scale, soared to record highs of between N950 and N1, 200, a dire situation that will result in a corresponding hike in the prices of essential goods and services.

A political analyst, Alex Nwadike, told *The Point*, "Seriously, if the President is thinking of coming on television again to tell Nigerians to endure hardship, the people will not listen to him.

⁷The President should realise that people have passed their elastic limits and are now experiencing breaking points. They can't endure again. And I dare say that if the President asked Nigerians to be patient and endure hardship yet again, they would insult him in the open.

"Have you seen the gloom in the land? How did we get here? Businesses are suffering and collapsing everyday and somebody still wants us to endure more hardship? Please, leave me out of that."

According to her, the pleas have not done anything to stop the general increase in the prices of her wares, some of which she can no longer afford to sell.

"Let no one come here to tell me about enduring hardship in this country. Is it when we die that Nigeria will be better off? Both the government and the friends of this government should spare us their pleas. We don't need it.

"I know you (referring to our correspondent) come to this market sometimes to buy foodstuffs. Is this how the market was last year? Or, are you journalists not affected by the hardship? "Just look around. For instance, I



Buhari, and had no option but to introduce a "painful but needed" end to oil subsidy.

Therefore, for the past 16 months since he took office, Tinubu has continued to acknowledge the severe impact his policies, including the floating of the naira, has caused but keeps assuring Nigerians that his administration is on top of the situation.

In July last year when Nigerians were already feeling the pinch as the prices of basic household items were shooting up, Tinubu pleaded with them, "I understand that our people are suffering; yet there can be no childbirth without pain

Tinubu has told Nigerians to put up with biting costs of living and skyrocketing inflation tearing households apart. He also promised that his administration was doing all it can to ameliorate the sufferings of beleaguered masses.

The latest appeal by Tinubu was made only last month. The President said via a video posted on X, formerly Twitter, by the State House, that "an avoidable lag" prevented his administration's "good and helpful plans" from coming to fruition.

He said, "Fellow Nigerians, this period may be hard on us and there's no doubt that it is tough, but I urge you all Another analyst, Benedict Njoku, said, "Well, if the President tells Nigerians to endure hardship, what can they do? The last time the people tried to do something about their situation, we all saw how it ended.

"The nationwide hunger protests, which could have been used to hold the government accountable, did not achieve much.

"Therefore, I am almost certain that Nigerians still believe in the ability of the government to turn their situation around. This should be the only reason why more Nigerians did not take to the streets during the protests in August."

He gave Anthony Joshua no chance to survive his dynamite blows. He did it before a capacity 96,000 crowd to retain his IBF heavyweight title.

He knocked out an unsettled Joshua who also arrived the Wembley Stadium late and cast an initial doubts on whether he was going to honour the fight.

A calmer and more confident Dubois arrived the arena an hour before Joshua showed up.

Now, Joshua's career is in ruins. An anticipated rematch with the Oleksandr Usyk is now a mirage.

The 27-year-old Dubois dropped Joshua multiple times to retain the IBF heavyweight title. Londoner Dubois stopped Joshua, 34, with an incredible councareer.

"Are you not entertained?" Dubois shouted after the post-fight, to huge cheers in the packed-out stadium. "I'm a gladiator. I am a warrior to the bitter end. I want to get to the top level of this sport and reach my potential.'

Joshua who won his first world title more than eight vears ago – suffered a fourth loss in his 32nd bout, but hinted he will continue in the sport and has a clause to trigger a rematch with Dubois.

You know I'm ready to kick off in the ring but I'm going to keep it respectful," he said.

"Before I came here, I always say to myself I'm a fighter for life. You keep rolling the dice."

An ecstatic Dubois, meanwhile, enjoyed the crowning moment which had eluded him after he was elevated to world champion when Oleksandr Usyk vacated the belt.

Bumbling Nigerian bureaucrats

Thitehall is a street in London that has bestowed its name on ministries of the British government. It also bestowed its practices and traditions on the civil service of Nigeria and most other Commonwealth countries.

The street is now a metaphor, like New York City's Wall Street and Broad Street, which respectively represent investment banking and dramatic arts theatres. Fleet Street, London, where the earliest British newspapers had their offices, is synonymous with journalism.

In addition, Whitehall is a symbol of the power and prestige of the British bureaucracy, as it is also steeped in intrigue and falsehoods that lead to the failure of ministers who weren't aware of the banana peels on its corridors.

Like its British progenitor, the Nigerian civil service, once described as an abyss by a senior journalist and columnist, is home of "capa y daga," or cloakand-dagger, intrigues, treacheries, lies, and large doses of incompetence. And that, unfortunately, is the system that runs Nigeria.

The political class that pretends to be ruling Nigeria is no more than a group of ignoramuses, led by the nose into the labyrinth of governmental machinery run by cunning civil servants who have near-permanent tenure within the bureaucracy.

It is these generally incompetent bureaucrats that administer the disastrous economic and political policies in Nigeria.

The World Bank doubted the competence of Nigeria's bureaucracy even from the early days of post-independence Nigeria.

When proposing Nigeria's First 5-Year Development Plan for 1962-1968, the World Bank observed that "it is doubtful whether the (Abubakar Tafawa Balewa) government's administrative machine, as at present staffed and organized, will be able to carry out public investment at the planned rate."

So, when you are impatient and lambast the "wobbling and fumbling" political class of Nigeria, remember that it is this calibre of unprofessional bureaucrats that have been providing them with counsel from the very beginning.



The bureaucrats have been as constant as the wall gecko in Nigeria's corridor of power. That is probably why the most senior officers in the civil service are styled "permanent secretaries." It takes a tortuous process to discipline or fire incompetent or erring civil servants.

The failure of Nigeria's bureaucracy in the last 64 years makes it clear that the economic and political fate of Nigerians is in the hands of incompetents, with their much-storied credentials, obtained from some of the academic citadels of the Western world.

If you look at the epileptic outing of Nigeria's energy "multiverse" which includes electricity and fuel for automobiles, homes, and industries, you will see a graphic representation of the cause of the quandary that Nigeria has sunk into.

Despite the many transformations and changes in the nomenclatures of the electricity provider, Electricity Corporation of Nigeria, to the National Electric Power Authority, National Electric Power Plc, Power Holding Company of Nigeria, and the spaghetti of names for now partially privatized electricity generation, transmission, and distribution companies.

The same incompetence is apparent in the running of the Nigeria National Oil Corporation, which was renamed Nigeria National Petroleum Corporation. It has a legendary incapability to provide enough fuel for Nigerians.

After a meeting with some International Oil Companies, former President Olusegun Obasanjo wisely sold Nigeria's refineries in Port Harcourt and Kaduna to billionaire businessmen, Aliko Dan-



gote and his pal, Femi Otedola.

The bureaucrats saw their cookie crumbling and quickly joined labour to prevail on Obasanjo's successor, President Umaru Musa Yar'Adua, to reverse the decision. He reacquired the refineries and returned them to the bureaucratic vultures.

The bureaucrats are simply lurking within the lumbering NNPCL, indulging in their private interests, while ramping up \$6.8 billion in trade debt, which has now become a roadblock to Nigerian motorists having a regular supply of petrol.

The bureaucrats, who famously kept the lie of fuel subsidy going in the public space, have now capitulated and admitted that the subsidy can no longer be sustained and the pump price of petrol must be hiked.

Recently, NNPCL surreptitiously increased the pump price in its petrol outlets. When Dangote Refinery offered to sell petrol and diesel at undisclosed prices said to be below that of NNPCL, marketers, allegedly encouraged by bureaucrats, rejected the products.

They preferred the imported products because it gave them legitimate access to foreign exchange. Maybe President Bola Tinubu should have allowed marketers to import petroleum products and see them compete with the expected lower cost of Dangote Refineries.

After failing to run NNPCL refineries, the oil bureaucrats cleverly sidetracked marketers and initiated a meddlesome plan to make NNPCL the sole off-taker of Dangote Refinery petroleum products, perhaps to look as if they are working. Still, the bureaucrats continued with their mischief.

porate Affairs Manager, announced that NNPCL paid N898.78 for petrol per litre from Dangote Refinery, it was compelled to respond that though NNPCL paid in Dollars (\$0.55), the price was lower than the current cost of imported petrol. NNPCL then disclosed that the petrol price for the Lagos market is N950.22 (or \$0.58).

Everyone knows that this is just a scheme to put NNPCL somewhere in the loop of the petrol supply chain. NNPCL should only sell crude petroleum to Dangote Refinery, collect its money, and leave the midstream and downstream sub-sectors alone. The perennially unresolved disagreements between the government and the Academic Staff Union of Universities reveal a horde of bureaucrats lurking in the crevices of failed negotiations and unimplemented agreements.

The involvement of bureaucrats in inconclusive negotiations dates back to the days of the Federal Military Government of General Yakubu Gowon, who issued a quit notice for striking dons to vacate their official university residential quarters.

The can of the problems continued to get kicked down the road to successive politicians who have no sense of the history of the failed negotiations and therefore have no clue on what to do to resolve the outstanding disagreements.



It sounds like the fulfillment of the mischievous quip, "Why do what can be done tomorrow, today?", something you often hear on the corridors of civil service premises.

Keen observers see in Nigeria a tribe of self-serving civil service bureaucrats who look out for their interests only and leave the devil to care for the citizens and their employers. Someone suggested that bureaucrats became more self-centered after former military Head of State, General Murtala Muhammed, carried out a massive purge of the civil service in 1975.

They claim that when serving civil servants saw that their tenure was no longer protected and that they could lose their jobs, pensions, and gratuities on the whim of a Head of State, they wisely opted to look after their interests only and relegated the business of governance to a secondary level on the totem pole of priorities.

There can be no justification for carrying out the business of governance in half measures. Any bureaucrat who is not prepared to give his or her best to the service of the nation should simply make way for those who will be more committed.

But let no politician think that this exonerates them from blame for causing pain to fellow Nigerians; this just happens to be the time to call out bureaucrats who hide behind seemingly unwary politicians.
